## MINUTES Washington County Fair Board

CONSENT AGENDA

MOTION: MOVED BY CHARLES COLEGROVE, SECONDED BY JERRY PFLUG TO APPROVE THE JUNE 3, 20, & 22, 1981, MINUTES; THE BILLS AS SUBMITTED; AND THE FINANCIAL RECAP FOR MAY 1981. MOTION CARRIED. (Bills listed on page 2.)

ME . ROOF

The Board reviewed a letter from County Counsel to Daniel McCabe, attorney for Bean & Duyck Roofing, reporting that the Fair Board will be filing action against his client.

BOARD TERMS Jerry Boyer will be leaving the Fair Board after serving seven years. Agnes DeLashmutt and Jerry Pflug's first terms will be ending in December. Director Hesse requested DeLashmutt and Pflug to let her know by September 1 whether they will be seeking reappointment. This will give the Board enough time to recruit new members if necessary. The Board of Commissioners also needs to be informed of vacancies.

RA CKERS The Board reviewed the Terra Trackers response to the Board that was published in the June 30, 1981, Hillsboro Argus. The Board recommended no further reply.

PA SYSTEM

An amplifier and microphone were stolen from the crows nest after the July 4 Destruction Derby.

MOTION: MOVED BY AGNES DELASHMUTT, SECONDED BY JERRY PFLUG TO REPLACE THE STOLEN EQUIPMENT, DEVELOP A SECURITY PLAN, AND PLACE OPERATING INSTRUCTIONS ON THE EQUIPMENT. MOTION CARRIED.

A security fee may be needed for groups using the equipment. An employee should also put up equipment and return equipment to office upon completion of events. Leaving the equipment in the boxes on the grounds is an attractive nuisance.

ELECTRICAL

The Board studied proposals from Pagel Electric, Inc., and Sunset Electric, Inc., for hooking up power for the new livestock barn. Sunset Electric's proposal included a larger cable that will be needed in the future.

MOTION: MOVED BY CHARLES COLEGROVE, SECONDED BY JERRY PFLUG TO CONTRACT SUNSET ELECTRIC TO HOOK UP POWER TO THE NEW LIVESTOCK BARN NOT TO EXCEED \$1,499. MOTION CARRIED.

The Board discussed the difference between mercury vapor and quartz lights. For the amount of use quartz lights will be adequate.

MOTION: MOVED BY CHARLES COLEGROVE, SECONDED BY AGNES DELASHMUTT TO AUTHORIZE HESSE TO ORDER 1500 WATT QUARTZ LAMPS FOR THE DESTRUCTION DERBY PIT AREA AND AUTHORIZING NECESSARY EXPENDITURE FOR INSTALLATION. MOTION CARRIED.

PGE will not provide a truck to help set a new pole and to install lights on two existing poles in the pit area. The existing poles are very old and are not safe to climb. PGE has helped in the past. GTE may have a truck to reach that high; Hesse will check.

Colegrove suggested moving the only night destruction derby to an afternoon event so extra lights would not need to be installed. Pflug pointed out the old bull pens need to be lighted to eliminate confusion.

FENCING

There are three different sections around the grounds that need new fence. It is not worth manning the gates during fair if people can walk in a bit further down the fence.

Sears will not guaranty fence for a public facility. Pacific Fence & Wire Company made a bid of \$6,135 for 1,233 feet of 6 foot fence without barb wire. Hesse is waiting for a bid from U.S. Steel.

MOTION: MOVED BY JERRY PFLUG, SECONDED BY AGNES DELASHMUTT TO AUTHORIZE HESSE TO CONTRACT THE LOWEST BIDDER FOR 1,233 FEET OF 6 FOOT FENCE AFTER ANOTHER BID IS RECEIVED. MOTION CARRIED.

D. DERBY

Net profit for the July 4 derby was \$6,879.53. This is \$1,000 less than 1980. The gate was down 620 admissions, but the pit gate was up. Hesse pointed out a few one time expenses such as flags.

The Arndt family complained about rocks flying through the fence. The Board is aware of the problem and the maintenance crew will continue removing rocks from the arena floor for the safety of all events and spectators.

Director Hesse will write a "letter to the editor" thanking the volunteer help and participants in the derby and listing examples of improvements made possible by the derby profits.

There will not be a separate lunch for the crew during the September 5 derby; they will eat at the concession stand.
