Minutes of the regular meeting held June 1, 1977

CALL TO ORDER AND ATTENDANCE Chairman Evers called the meeting to order at 8:37 p.m. at the Fair office with the following in attendance:

RODEO & FAIR

Past problems of rodeo security were identified and solutions SECURITY FOR 1977 discussed. The grandstand and internal area will be cleared at 6:00 p.m. and guards thereafter put on gates to maintain security.

> Fair Board asked Essam to have a rodeo person available at the north drive through gate and a rodeo person at the swing gate. A Fair person will be with each rodeo person. A list of contestants shall be prepared, by the rodeo committee, and used for the actual admission.

The Fair Board set as a guideline for security responsibility the following: Rodeo Board responsible for internal security and Fair for perimeter control. Mrs. Hesse said she would hold a meeting to include Washington County Reserve Representative, Hillsboro Police Chief Woll and Rodeo committee security personnel. A report will be presented at the July Board meeting.

JOSSY RESIGNATION Richard Jossy sent a letter to the Fair Board and stated he wished to resign as Fair Manager effective June 1, 1977.

Mr. & Mrs. Jossy will be invited as honored guests to a dinner, hosted by the Fair Board, at the Brown Derby on June 17 or 18. Mrs. Hesse to check dates and notify the Board. Lifetime pass will be presented at that time.

WATER LINE

Evers commented on the long distance required to carry water from show rings. Mr. Mohr will check for line on the West side of 4-H FFA livestock barns.

PERMANENT SIGN NORTH GATE

Board asked Mohr to construct and install permanent sign on Cornell Road entrance to the Fairgrounds. Sign to read "North Gate".

Additional sandwich boards will be made for the purpose of directing traffic and marking entrances during County Fair. HILLSBORO SR.

Ed Wolfe, on behalf of the Hillsboro Sr. Soccer Club, presented a proposed drawing for semi-permanent soccer field to be located on the northeast corner along Cornell Road. Location is good for possible spectator crowd. The event is growing very fast according to Wolfe and in the future a small charge could be made.

MOTION. MOVED BY RALPH HOLLAND SECONDED BY JERRY BOYER TO RECOMMEND TO THE BOARD OF WASHINGTON COUNTY COMMISSIONERS TO ENTER APPROXIMATELY A THREE YEAR RENEWAL USAGE LEASE WITH THE HILLSBORO SENIOR SOCCER LEAGUE FOR SEMI-PERMANENT SOCCER FIELD ON THE NORTHEAST CORNER BORDERING CORNELL ROAD. MOTION CARRIED.

Wolfe asked if the Fair Board would rope off the current soccer field in the main parking lot during Happy Days and County Fair. The Fair Board denied request as the County Fair is the primary project of the Washington County Fairgrounds and the parking is vital.

Wolfe was given permission to fill dirt and replant the south end of the soccer field and also fill the rut at the Fair entrance.

REJECT ROCK PROJECT Joe Evers reported cooperatively working with the County Road Master on obtaining reject rock for the 4-H FFA livestock barns and foundation of the poultry building.

MOTION: MOVED BY RALPH HOLLAND, SECONDED BY CHARLES COLEGROVE TO ALLOW \$300.00 TO DEFRAY COUNTY COSTS FOR 200 YARDS OF REJECT GRAVEL. MOTION CARRIED.

1977-78 BUDGET

The Fair Board request of \$81,202., from Washington County was cut to \$21,000. This necissitated revising the entire budget. The Board reviewed the 1977-78 budget for the second time and adopted the following budget revenue and expense items also change in line items.
