Minutes of the regular Board meeting held June 2, 1976

PRESENTATION
RE MUSEUM LOCATION

Lambert indicated he represented Washington County Museum as an element of County government. He is not representing the Historical Society of Washington County.

Lambert would like as a first step to get a mutual understanding regarding the possibility of locating the museum on the fairgrounds. He indicated the County endorses the concept of mutual siting. A County museum multi-purpose map was shared with the Board. The map was designed by Robert E. Meyer Engineers, Inc. Funding a museum building would have to be financed by a county levy.

The Fair Board voted to give Lambert a confidence vote and the following motion resulted.

LIFETIME PASS FOR ED BALL It was suggested by management that Ed Ball be awarded a lifetime pass for many years of service to the Fair.

DONATION OF ARENA BARN COMPLEX

The Fair Board received a letter offering an existing arena barn complex, a structure of about 120 feet by 140 feet from a donor who wishes to remain anonymous. The Board discussed the offer and methods that could be employed to move the structure with minimal damage. Boyer indicated he has located donated equipment needed to do dismanteling or relocating the donated arena barn complex.

All Board members and management felt an expert would need to be hired to dismantel the barn complex. DONATION OF ARENA Letters to donors and to those holding Expo funds will be BARN COMPLEX (CONT.)sent June 4.
