Mr. Girard will compute and tabulate the bids and send the information to all bidders. The bid was termed as a fairly tight bid as the County Engineer's estimate was \$16,000.00.

Mr. Jossy questioned Mr. Girard as to the approximate cost of the Engineering of the job. Mr. Girard commented that 10% is generally the fee charged by the County Girard and Robison were thanked for their cooperation and speed with which they had displayed ingetting the project going

JULY 2, 1973 BID AWARD

If a bid is awarded it will be done on July 2, 1973. Signing of papers to take place at this time. Approximate construction time is estimated at two weeks.

RECREATION STUDY

Legal aspects of a long term lease were discussed by the Board. Dr. McGough said the City of Hillsboro is concerned about spending time and money when they are not sure of the authority of the Fair Board has in juristic power of the fairgrounds. It is gathered from what County Counsel, Ed Sullivan has told Mr. Jossy that the County Commissioners have the right to move the fairgrounds. Mr. Jossy will visit with Eldon Mills, City of Hillsboro Manager to arrange a program for long term use of proposed ball parks.

Mr. Springer said he would like a meeting set-up with the City after the Fair.

LONG RANGE PLANNING

Mr. Jossy read a new long range plan for the fairgrounds. Mr. Springer would like LONG RANGE PLANNING (CONT.)

to approach an engineering planning specialist with the thought that we cannot afford much but want to plan ahead for the future. Possibly several firms could be alerted before the Fair. Mr. Adams said we should list our needs and see if the County would make a long range plan. Mr. Adams stressed the importance of proper utilization of our land to avoid costly waste and error.

BANNERS FOR RODEO

Dr. McGough approached the Board about purchasing banner to advertise the rodeo Banners could not be used this year as the rodeo dates were to close for banner to be completed. The Board will conside the idea for next years budget.

MERIT RATER

Jossy said that Mr. Bill Gillespie, our 1973 Merit Rater would like a meeting set-up with the Board during his visit to the Fair. Wednesday, August 1 at 9:30 p.m. has been set. Mr. Adams offered use of his Motorhome for a social hour.
