WASHINGTON COUNTY FAIR BOARD MEETING.

June 28, 1934.

A joint meeting of the Fair Board and the Masters of the Granges of Washington County was called for this date, Thursday, June 28, 1934, at 8:00 P.M., in the Chamber of Commerce rooms. Those present were - members of the Fair Board - Banks, Minton and Hesse; Pete Johnson of the Cedar Mill Grange, Oscar Hagg of the Aloha Grange, and Jas. Forsythe of the Hillsboro Grange. President Banks presided.

The minutes of the last meeting were read and approved. President Banks then stated the object of the meeting was the discussion of the Grange exhibits for the 1934 Fair, and called upon Mr. Minton for further explanation.

Mr. Minton spoke for a few minutes saying that the money being scearce this year it would be necessary to cut the expenses, and one plan for the Grange exhibit would be a combined exhibit, and that the \$50.00 which in former years had been given the Granges would have to be cut in two.

Mr. Hesse said he was not so much in favor of a combined booth, and thought it would be better to pay \$25.00 or \$30.00 to each Grange separately the same as before.

Mr. Hagg said he would recommend continuing the exhibits separately and appropriating the money as was available.

Mr. Johnson said that he had heard much talk in favor of each Grange exhibiting the main products of their locality.

Mr. Forsythe coming in at this time argued a little in favor of extending the premiums in live stock to others than the 4H club members.

It was the unanimous opinion of those present that the Fair Board should use the money according to their best judgment.

It was moved by Hesse, seconded by Minton, that the Fair Board appropriate \$25.00 to each Grange exhibiting or putting in an independent booth at the Fair, and give them the privilege of featuring the products grown in their own community as best they could. They could, of course, exhibit other products as well. Motion carried.

Mr. Johnson asked if the exhibits were to be taken to the International Exposition. Mr. Minton said it was optional with the different Granges. Mr. Minton suggested that if the International Exhibition should pay for a combined Washington County exhibit, that the Fair Board should make that sum up to \$200.00, that is if the International paid \$80.00 that the Fair Board should pay \$120.00

After some further discussion the Grange Master withdrew, and the Fair board had a short meeting.

Board Meeting, June 28, continued.

It was moved by Minton, seconded by Hesse, that Mr. Moore be again elected as manager, and Mr. Banks and Mr. Hesse should agree with him on terms. Motion carried.

Moved by Hesse, seconded by Banks, that Mr. Minton and the manager revamp the premium list, and call another meeting of the Fair Board. Motion carried.

Upon motion the meeting adjourned.

Moved by Minton, seconded by Hesse, that the fair dates for 1934 be August 30, 31 and September 1. Motion carried.

The matter of appriating \$200.00 for grange exhibits at the Fair, and \$200.00 for a combined Grange exhibit at the Pacific International Exposition was discussed but no action taken.

It was moved by Minton, seconded by Hesse, that the next meeting be held Thursday night, June 28, at 8:00 P.M., and the secretary was instructed to notify the masters of all the Granges to be present. Motion carried.
