Minutes of the Regular Board Meeting Held June 4, 1975

CLEAN UP OF OLD BARN AND PAYMENT Bruce Minter reported clean-up has been completed with the help of the City of Hillsboro. Existing well has been capped for possible use by the City.

Minter gave the following accounting of funds: Funds collected \$354.00; Accounts receivable, \$550.00; for a total of \$904.00.

Approximate Value of unsold lumber: \$600.00 - siding and 21 beams @ \$50.00 each \$1,050.00. Total value \$1,650.00.

Sold materials \$904.00, unsold \$1,650.00 for a total of \$2,554.00. The Group seems to be having difficulty in marketing the lumber. Loss in lumber was great because the barn had to be pulled over to meet insurance requirements.

Giving the Group an extension of time to pay funds was discussed. Also, letting the Cadets work off a certain amount for security work during the County Fair at \$5.00 per hour. It was noted that the Cadets would be under supervision at all times. Management will work out a scheduling of hours.

PRIME STOCK SALE
OBJECTIVES AND REPORT

Bill Winter representing Beaverton Rotary Club and Prime Stock sale committee updated the Board as to the activities and plans for the Prime Stock sale to be sponsored jointly by the Washington County Livestock Assn., Beaverton Rotary, and the Fair Board. Winter said three advance mailings would be made to the following: all chamber of commerce members in the county, possible businessmen who would attend and purchase, and previous buyers. Chairman Springer passed out an agreement written by his attorney for review. The agreement did not meet the needs and was therefore discarded. Chuck Colegrove will serve as liaison for Fair Board.

PRIME STOCK SALE (CONT.)

MOTION. MOVED BY JERRY BOYER, SECONDED BY RALPH HOLLAND, TO ADD LINE ITEMS TO THE 1976 BUDGET TO ACCOMMODATE THE INCOME AND EXPENSES OF THE PRIME STOCK SALE AND PROVIDE OPERATION COST FUNDS TO THE PRIME STOCK SALE COMMITTEE IN 1976. M.C.

Management will contact Leonard Adams Insurance regarding protection of animals after purchase at the Prime Stock Sale.

1975 OPERATIONS PLANNING

The Board and Management discussed the best method of organization for special events and all regular events that take place during the fair. It was agreed that a man should be hired for one week to handle special events. The Fair Board members will assume responsibility of helping to run work crews. Jerry Boyer volunteered to be in charge of functions at the arena and clean-up of grandstand.

SHOWRINGS

4-H Livestock Board has suggested that the present show rings be removed and that spectators sit on straw bales. In addition they would like the size of the show rings increased.

Fair Board will allow moving them east and enlarging them, however, board show rings and bleachers will be used as in the past. The clerking shed will have to be put on skids.

EQUIPMENT RENTAL AND PURCHASE

Al Mohr is purchasing a post hole auger and has offered to rent the auger to the Fair Board for \$10 per day. The Board accepted the offer.

Mohr asked the Board to consider purchasing a bucket for the tractor to move barkdust, rock, earth, etc.

BARK CHIPS IN ARTS & CRAFTS BLDG.

Barbara Olson, Arts & Crafts department, helper, asked if bark chips could be placed on the floor of the Arts and Crafts building. The Board denied the request because of possible fire hazard.

APPARREL FOR WORK CREW DURING FAIR

Don Davidson has offered to sell short sleeved coveralls to the Board for \$10 per pair. The Board would like to have the crew look neat and be easily identifiable. Possibilities discussed include tee shirts and vests. Management will make final decision.
