TERRA TRACKERS REPORT ON 4-WHEEL PLAYDAY Gordon Scott, President of the group said the event was a big success and the fairgrounds worked out very well for them. Total expenses have not been compiled and therefore 50% of the net due the Fair Board will be paid after the groups June 18 meeting. Fair manager Jossy complimented the Group on their conduct and management of the event. Only problems the Fair encountered were complaints on noise of the P.A. system and rough language used by the announcer. Scott told the Board that at no time did the noise level go over the 62 deciple allowed by the Department of Environmental Quality. County and State Police were present for part of the event as well as the Hillsboro fire department,

WASH. CO. SHERIFFS POSSE WILL PUT ON BREAKFAST Len Campbell and Vern Weible talked about the Rodeo breakfast. The main problem last year seemed to be lack of publicity of the event. It is hoped that the Rodeo Committee and the Posse will coordinate the event and the Public Relations Firm hired by the Fair Board will help to publicize the breakfast.

RODEO COMMITTEE -BREAKFAST LOCATION Orville Schoen representing the Rodeo Directors recommended the breakfast be held downtown Hillsboro with a parade to come to the fairgrounds. Schoen has access to a portable power plant which will be furnished by P.G.E. for cooking the breakfast. Schoen further feels the breakfast will boost the downtown businessmen. The Posse and Rodeo Board agreed to hold the breakfast downtown Hillsboro. Breakfast to be held August 3, Saturday, from 7:00a.m. - 11:00 a.m.

REQUEST FROM EYC

The Extension Youth Council a group of young 4-H men and women would like to clean up and install a Franklin fire-place and carpeting in the 4-H building. EYC would like the Fair Board to furnish paint. Target date to start cleaning up is June 17. The Group does understand that other groups will be allowed to book and use the building. EYC will have first choice of meeting dates which should be presented to the Fair Management in advance. Springer will ask Beaverton Rotary to donate funds for paint and new doors.

4-H HORSE ADVISORY UPDATE

Jerry Boyer representing the 4-H Horse Advisory Board gave an update report on fund raising for improvement of horse facilities. Boyer said \$2,000 had been raised with the goal at \$3,500. He then asked for a financial commitment from the Fair Board to reach the goal. At this point at the suggestion of Ralph Holland the group went out to look at the present facilities. Upon returning it was agreed by both parties that the funds raised by the 4-H Groups would beused to fix up the present facility.

Boyer invited Fair Manager Jossy to visit with the 4-H Horse Advisory Board Tuesday, June 11 (7:30 p.m.) at the Extension Office. Jossy will update the Group on activites and long range proposals of the Fair.

Addy Hesse read a list of bids for coveralls for the workcrew during the Fair. Color available is Navy blue.

INLET-OUTLET ANTIQUES REQUEST TO RENT M.E.

Don Richardson, Inlet-Outlet Antiques would like to rent the South end of the Main Exhibit Building immediately after the 1974 Fair for 1974-75. The Fair Board will allow Richardson to use the South end of the Main Exhibit Building and the Board is willing to renegotiate terms after the 1974 Fair.

GROUNDS REPORT

Ed Ball reported the Green Thumb crew is working on various projects around the fairgrounds.

FAIR ENTERTAINMENT

No entertainment for 1974 has been contracted according to Jossy. A letter from a clown offering service was read to the Board. Jossy will call and interview the clown for possible youth entertainment at the 1974 Fair. Amateur talent will be used for Wednesday and Thursday and the

FAIR ENTERTAINMENT (CONT.) Grange will present a variety show on Friday evening.

Saturday night will include the Prime Stock Sale and Rodeo.

The main problem has been lack of budget to procure services for entertainment. Springer will contact a group and report back to the Management. The Fair has traditionally had a free entertainment for the youth of the Fair and Jossy feels this is important to the future growth of the Fair.

ETHICS COMMITTEE LETTER RE: MARTIN Cascade Arabian Horse Club Inc. has sent a letter to the Fair Board and has asked the Board to write to the Ethics Committee of International Arabian Horse Assn. and reflect on problems with Expo funds and Robert Martin, an ex-member. The Club has also sent a list of the new Horse Show Committee.

Manager Jossy read a letter he had drafted to the Ethics Committee and the Fair Board authorized the letter to be sent.

WASH. CO. WESTERNERS

Don Wiley, president of the Wash. Co. Westerners contracted to use the fairgrounds, specifically the arena and concession stand for May 19, 1974. On that date several other events were taking place on the fairgrounds. The Group protested their written rental agreement because they could not use the arena for 25 minutes because the Boys Scouts of America were holding a brief church service and also because Mr. Wiley did not understand the rental price. He told Jossy in a telephone conversation that he did not want anyone else using the fairgrounds when the Westerners were using the arena. Jossy explained that the Board trys to provide a community service for non profit groups through out the County at nominal fees for the good of all. The Westerners will be sent a letter and statement for the balance due for use of the facilities. The Fair Board cannot allow anyone person or Group to set prices for use of facilities.

LIONS CLUB REPORT

Jossy and Chuck Colegrove attended the Lions Club Breakfast and asked the Group to consider giving a contribution for the improvement of Prime Stock Sale facilities. At a later meeting the Lions Club agreed to make some donation back to the fairgrounds for improvement of the Sale.

FUTURE PRIME STOCK SALE - 1975 Springer said he would like to see the future Prime Stock Sale go on a bid basis. The Rotary Clubs of Washington County under the direction of the Beaverton Rotary Club would like to put on the sale and donate all the profits back to the fairgrounds.
