CONSENT AGENDA

MOTION: MOVED BY JEANNE LEESON, SECONDED BY JOHN MEEK TO APPROVE THE APRIL 1985 FINANCIAL RECAP, MAY 1, 1985 FAIR BOARD MINUTES, APRIL 1985 OFF-SEASON CALENDAR, AND THE BILLS FOR APPROVAL (Bills listed on page 2). MOTION CARRIED.

RODEO BOARD REPORT

The Fair Board reviewed minutes from the May 6, 1985 Rodeo Board meeting. Rocky Williams, Rodeo Board Chairman, presented a proposal to move the bleachers in the north end of the arena. Addy Hesse, Executive Director, received a quote from Safway Scaffold of \$4,500 to simply move the bleachers. Hesse solicited a bid from C.M.F. Landscape & Concrete. They indicated they would rock, apply weed killer and move bleachers for \$1,920. For an additional \$2,775 they would replace the boards and hardware on the bleacher seating. The present condition is marginal and Hesse recommended moving the bleachers to the proposed area and replacing the wood seating on the same.

MOTION: MOVED BY LLOYD BARON, SECONDED BY JEANNE LEESON, TO MOVE THE BLEACHERS TO THE NORTH ARENA PER ROCKY WILLIAMS PLAN "A" DRAWING AND REBUILDING THE WOOD SEATING ON THE SAME. MOTION CARRIED.

Hesse said the bleacher frames would be sandblasted and painted this fall. Williams suggested the bleachers have fencing surrounding them to prevent someone from falling.

GRADER USE

A letter from Washington County Land Use and Transportation was read, outlining grader costs for the derbies and during the fair.

PARKING LOT LIGHTING

Hesse reported she would be meeting with PGE regarding installation of underground cable for the parking lot lights. Cost could be as high as \$18,000. Hesse recommended rental rather than purchasing therefore the responsibility for repairs, maintenance, and vandalism lies with PGE.

MOTION: MOVED BY LLOYD BARON, SECONDED BY JEANNE LEESON TO AUTHORIZE HESSE TO NEGOTIATE AND CONTRACT WITH PGE REGARDING LIGHTING IN THE 34TH AVENUE PARKING LOT. MOTION CARRIED.

HOTEL/MOTEL TAX REVENUE

John Meek reported, according to Don Stilwell, County Administrator, that hotel/motel tax revenue for three quarters of the year is slightly over \$100,000 for each percent of collection. Hesse was told by Bob Davis, Senior Analyst, that supplemental (1985-86) budget could be supplied to the County by July 18.

BOAT STORAGE

E.G. Hoppe, boat storage customer, experienced vandalism to his boat while stored in the Poultry/Rabbit Building. Hesse recommended returning the fee paid for storage with a letter of apology. A proposed letter to Mr. Hoppe was approved by the Fair Board and Hesse has permission to return his storage fee.

PARKING LOT

Seven qualified bids were read on Thursday, May 30, at 10:00 a.m. Low bid was from Clearwater Construction in the amount of \$216,317.50. The high bid was \$328,237.15. Carl Jensen of Consulting Engineering Services and Hesse recommended contracting with Clearwater Construction. Jensen indicated they could cut back on excavation, woven fabric, and PVC pipe. Jensen also stated that certain bid items could be adjustable during construction and the Fair Board should enter the contract with that knowledge.

MOTION: MOVED BY LLOYD BARON, SECONDED BY JOHN MEEK TO CONTRACT WITH CLEARWATER CONSTRUCTION COMPANY WITH THE KNOWLEDGE AND UNDERSTANDING CERTAIN ITEMS MAY ADJUST DURING CONSTRUCTION OF 34TH AVENUE PARKING LOT. MOTION CARRIED.

MAIN ENTRANCE DESIGN

Stan Rickard, architect, presented several options to the Fair Board concerning the Main Entrance design. Independent roof structure, pre-fab ticket booths, reducing number of ticket booths, allowing for expansion, basic power, glass roof and other options were discussed at lenth. Rickard indicated the project needed to be scaled down to meet budget. Rickard and Hesse will meet and bring a recommendation to the July 10, 1985 Fair Board meeting.

READERBOARD/SIGN

Hesse reported she was working on getting the illuminated readerboard/sign installed before County Fair.

PREMIUM BOOK DISTRIBUTION

Fair Board members volunteered to distribute premium books throughout Washington County at various businesses.

MARKETING

Hesse has been working with Hallmark Inn on co-marketing the facilities for regional and state events. Court Carrier is no longer with the Hallmark.

ACTIVE 20/30 CLUB

The Action 20/30 Club painted the recycle center. They will also be upgrading the landscaping.

COMPUTER DONATION

John Meek and Carl Story are donating an Apple III computer to the fairgrounds office. We are getting close to delivery of the system. We will be looking at purchasing a dot matrix, letter quality, printer. Thank you John.

FREEZER DONATION

The Tualatin Valley Men's Garden Club and the Hillsboro Rotary Club donated \$1,350 towards the purchase of two freezers for the Land Products Department.

CLOTHING RACK DONATION

Fred and Esther Wallender donated two clothing racks for the Clover-leaf Community Building.

PARKING EXEMPTIONS

A list of possible exemptions for paid parking was presented to the Fair Board. The board consensus was that the proposed exemptions were acceptable and that Hesse had authority to alter if necessary.

VANDALISM

R.V.'s stored in the outside barns were vandalized during the past storage season. Hesse remarked that before utilizing those facilities the building sides would have to be secured. Homer Speer suggested hiring a security guard. John Meek suggested looking into the possibility of a closed circuit monitor.

DERBY RULES

The Washington County Derby Drivers Association submitted a new rule to Hesse which was incorporated into the 1985 rules. Hesse received numerous complaints regarding the rule. Drivers were concerned with the hardship it would cause financially and due to the time frame before the first race. Hesse recommended the rule for 1986 and to clarify the 1985 rule. Board members agreed with the recommendation.

34th AVENUE

The State will be leaving the rock they put down on 34th Avenue at no cost to the fairgrounds, as it was their error.

PAGER

Hesse contracted for a voice activated pager to be worn by Ron. Cost is \$22 per month, which includes repairs and maintenance, voice time, loss and theft insurance. This will eliminate the need for a radio during fair week.

TELEPHONES.

Hesse had push button telephones installed on May 14th. This will allow for the use of the voice activated pager.

COFFEE MUGS

Washington County Fair & Rodeo coffee mugs are available. Some will be sold at \$1.50 and the balance will be given to superintendents, volunteers, and V.I.P.'s. Cost to fairgrounds for each cup is \$1.14.

STORER CABLE INTERVIEW

Hesse did an interview on May 30 with Storer Cable on fairground summer activities and fair highlights. It will be part of a "What's Happening in Washington County" program.

MILK PARLOR SUPERINTENDENT

Julie Hering was hired to fill the Milk Parlor Superintendent position.

FAIR PROGRAM

Christie Gray was hired to write articles and take photographs for the fair program and for off-season events.

TICKET TAKERS/SELLERS

If Fair Board members know anyone, 17 or older, interested in working as ticket takers or ticket sellers during the week of the fair, have them contact Hesse at the fair office.

FLOWER BEDS

The Washington County Garden Clubs planted flowers on May 17. The plants were donated by Iwasaki Brothers.

OPEN CLASS PREMIUMS

Glen Ireland has offered \$250 for additional Holstein Dairy Open Class premiums, if matched by Fair Board or others. Up to \$50 of this donation should be used for Herdsmanship prize.

MOTION: MOVED BY LLOYD BARON, SECONDED BY JOHN MEEK, TO MATCH GLEN IRELAND'S \$250 CONTRIBUTION TOWARDS ADDITIONAL OPEN CLASS HOLSTEIN DAIRY PREMIUMS. MOTION CARRIED.

OPERATIONS REPORT

Completed May projects were, removed R.V.'s from storage, planted flower beds, painted west ticket gate, repaired plumbing in Chuck Wagon and fertilized lawns. June projects consist of building portable planters, painting Men's Livestock restrooms, and painting the ticket booth at the arena. Jeanne Leeson commented that the fairgrounds looked really nice.

ENTERTAINMENT.

Rocky Williams suggested bringing a portable stage into the arena on Tuesday night for Stella Parton's performance, rather than Friendship Square, to allow for more seating and better viewing. Hesse said she was negotiating for Off-Road Race Cars and a Draft Horse Show in the arena on Tuesday night. She also said there was a lot of expense involved with bringing a portable stage in, i.e. lighting and P.A. system.

PLANNING SESSION

Comments regarding the May 8, 1985 planning session were made. John Meek suggested a wrap-up session. Speer indicated Hesse needed to respond to objectives from the planning session and bring that back to the board. Hesse said she would be unable to work on the project until September, at which time a wrap up meeting will be scheduled.

BUDGET ADJUSTMENT

Hesse told the Board with the number of capital projects undertaken close to the end of the fiscal year, it is apparent that the capital outlay section of the budget will be exceeded.

Wages and Salaries are under spent and money can be appropriated from that section of the budget. The total of the budget cannot and will not be exceeded. The Board concurred with the adjustment.

NEXT FAIR BOARD MEETING

The next Fair Board meeting will be July 10, 1985 at 4:30 p.m., in the fairgrounds office.
