The Mashington County Fair Board was held on the above date in the fair office. The meeting was called to order at 8:20 p.m. by Chairman, Al Lindow. Those Board members present were McGough, Adams, Lindow, VanDyke, Jossy, aBall and Addy Hesse. Guests for the evening were: John Guyer, Margaret Sahnow, and the Portland Community College Board of Directors; Dr. Amo DeBarnardis, president; Roy Lindsay, planning staff; Hugh McGilvra, board member; Ed Wagner, planning staff and Dr. Bob Bissett, board member.

Mrs. Margaret Sahnow came to urge the Fair Board to authorize additional funding for remodeling the Floral Building. Mrs. Sahnow told the Board that \$500 had been collected for the remodeling. Mr. Ball reported that approximately \$450 will be needed for the outside and \$259 for a linch plastic wire mesh; making a total of \$609. Mr. Additional moved that the Board profit the additional cost for remodeling the present Floral Building. Mr. VanDyke seconded. Motion carried.

At 8:30 p.m. on behalf of the PCC Board, Mr. Hugh McGilvra made a presentation urging 1) Washington County Fair Board to purchase a site near the proposed 'Rock Campus' 2) Washington County Fair Board and Portland Community College provide jointly facilities that the whole community could benefit from. Mr. McGilvra asked that the Board seriously consider the proposals and entertained a follow-up meeting between the two Boards.

Mr. Jossy told the Board that the Touch and See Animal Barns were completed at a cost of approximately \$700. Discussion was held as to where the barns should be located. No decision was reached.

Fir. Benson's tent has been rented for commercial booth space. Also, several other changes have taken place for commercial booth space. They are as follows: with elimenation of four booths on the far north end of the main exhibit building the land products show will be on the east side of the main exhibit building. This will allow Home-ec and Textiles additional space. Secondly, the non Arts and Crafts commercial booths have been taken out of the hobby hall.

Mr. Jossy read a letter from Tacky The Clown explaining his format. He will be paid on the last day of the fair (375.00).

A bid on bleachers was read from Safway. Without the needed cement footings cost would be \$7.50 per seat. After a lengthy discussion the Board decided to check into a purchase lease program. A special meeting will be called to consider the matter.

For the 1972-1973 budget, Mr. Jossy announced that we had procured \$3,000 from Washington County.

After a brief discussion the Board decided not to have counters at each gate.

Mr. Earl Adams moved we pay Ed Mortman \$140.00 per month for all 12 months effective May, 1972. Joe VanDyke seconded. Motion carried.

A motion was made by Ken McGough to ammend the March minutes to read the same signatures for 1972 will be authorized with the exception of Betty Shearer to be replaced by Adeline Hesse. Joe VanDyke seconded. Motion carried.

The minutes were approved as corrected, correction being McGough was a member present at the May meeting.

It was announced that Jeri Doctor was hired to handle publicity for the 1972 fair.

Rodeo tickets will be ordered by the fair office. Cost of admittance will be \$2.00 per ticket. Ken McGough coid the Rodeo committee was looking for a special gift for the All Around Cowboy. He would like suggestions on something original and indicative of Washington County.
