Minutes of the Regular Board Meeting Held March 10, 1976

CALL TO ORDER AND ATTENDANCE

Board Chairman Jim Springer called the meeting to order at 8:00 p.m. at the fair office with the following in attendance:

JAYCEE NEGOTIATIONS

Jaycees presented (in written form) three financial proposals to the Fair Board for usage of the fairgrounds for 1976, 1977 and 1978. First proposal: 3 year contract - first year \$2,250, second \$2,500 and third \$2,750; second proposal: 4 year contract @ \$2,500 per year; and third proposal: Jaycees buy material for pole barn. Furnish labor and build it (for 3 years free rent).

MOTION. MOVED BY JERRY BOYER TO ACCEPT PROPOSAL THREE FOR COMPLETION OF A 40 \times 80 (MINUS OR PLUS) POLE BUILDING TO BE CONSTRUCTED BY 1977 COUNTY FAIR. Motion died for lack of a second.

MOTION. MOVED BY RALPH HOLLAND, SECONDED BY JOE EVERS TO ALLOW JAYCEES USE OF THE FAIRGROUNDS FOR 1976 (ONE YEAR) CONTRACT FOR \$2,750.00 PLUS ALL UTILITIES (POWER AND GARBAGE). THE VOTES WERE RECORDED AS FOLLOWS: NO Jerry Boyer, Joe Vandyke. YES Joe Evers, Ralph Holland. Jim Springer then cast a no vote. Motion Failed.

More discussion continued and the Board decided to check into more specific building costs and size. Donated and paid labor were discussed and Jaycees indicated that their labor should be considered part of the cost of the building. They are not interested in donation labor on the pole building. Another motion evolved because the Jaycees felt they could no longer wait because they are in the process of getting out promotion, etc.

MOTION. MOVED BY RALPH HOLLAND, SECONDED BY JOE EVERS, TO ALLOW JAYCEES USE OF THE FAIRGROUNDS FOR A COST NOT TO EXCEED (FOR 1976 ONLY) \$2,750.00 PLUS UTILITIES (POWER AND GARBAGE). MOTION CARRIED UNANIMOUSLY.

Manager Jossy will contact Hershel Plummer regarding pole building specs and designs. The Fair Board will visit with the Jaycees at a March 24 special meeting.

FEBRUARY 18 MINUTES

BUDGET CORRECTION IN MOTION. MOVED BY JOE EVERS, SECONDED BY RALPH HOLLAND, TO AMMEND THE FEBRUARY 18 MINUTES THAT READ: "MOTION. MOVED BY JOE EVERS, SECONDED BY RALPH HOLLAND TO ADOPT \$195,055 INCOME AND \$195,055 EXPENSE FOR THE 1976-77 BUDGET SHOULD BE CORRECTED TO READ \$179,055 INCOME AND \$195,055 EXPENSE DIFFERENCE COMPENSATED BY CARRY OVER OF \$16,000 IN THE CAPITAL ACCOUNT. MOTION CARRIED.

Meeting will be set up with Board of County Commissioners for March 17 or 24 at 3:00 p.m. at the fair office to discuss proposed 1976-77 budget and long range plan completion. Dinner will be held at Marika's after the meeting and the Fair Board will return to the fair office for a meeting.

RODEO BOARD MINUTES

Rodeo Board minutes are being received and March 10 minutes were read to the Fair Board.

EXPO CENTER UPDATE

Ralph Holland reported that Gaston School district has signed a contract to remove the arena building. He further indicated if there is a breach of contract, the arena building will be donated to the Fair.

Board discussion centered on whether to wait for Gaston School district arena building or to start on an alternate plan for at least phase I of the expo building plan. The Expo Committee is instructed to devise several alternative plans for building or upgrading present facilities so that a letter can be sent donors asking for approval of alternatives or suggestions and approached for funds.

Jossy will explore who will have responsibility for maintenance and upkeep, etc.

FAMILY DAY PRICE SET

Having Family Day for Tuesday, August 3 (opening day of the Fair) was discussed and Management recommended a Family Day Ticket for a \$5.00 maximum. Rides also will be reduced to 4 for \$1.00.

MOTION. MOVED BY JERRY BOYER, SECONDED BY JOE EVERS TO HAVE A AUGUST 3 FAMILY DAY WITH A SPECIAL FAMILY TICKET PRICE OF \$5 MAXIMUM PRICE. MOTION CARRIED.

RIGHT TO LIFE BOOTH REQUESTING SPACE

Gary Duyck, representing the Right To Life organization, has asked for commercial space at the 1976 County Fair. The organizations name will be put on the waiting list. The Board will discuss display material used after a picture is presented.

OPEN CLASS ENTRY FEES RAISED Brief discussion centered on possibility of giving trophies to breed champions and Special Rosette ribbons to all competition winners at the Fair. Cost was also discussed. Jerry Boyer recommended raising entry fees 50¢ to help defray cost of rosettes and or trophies. Joe VanDyke indicated that he felt quite a few youngsters were involved and that the fee probably should not be raised.

OPEN CLASS ENTRY FEES RAISED (CONT.) After discussion, it was agreed to raise the entry fee from \$2.50 to \$3.00 for 1976. Boyer will get price bid by next board meeting. The Board generally favored only a nice rosette ribbon.
