NOMINATION BY JIM SPRINGER, SECONDED BY JOE VANDYKE THAT KEN MCGOUGH BE TREASURER OF THE BOARD AND MOVED THAT A UNANIMOUS BALLOT BE CAST BY THE SECRETARY. MOTION CARRIED.

ASSISTANT FAIR MANAGER

Jossy asked the Board to consider someone who could replace him in the event that he would no longer be the Manager. He suggested that someone be hired for a mouth or so in the summer to be come acquainted with the job. Mr. Jossy will again hire a special events director for the week of the fair. No Board action was taken.

FAIR BOARD POSITION ON LAND LEASE Dr. McGough will report to the Park and Recreation Committee that the F_ℓ ir Board would like to continue negotiations with the City of Hillsboro in regard to the land lease agreement for the ball park.

RODEO COMMITTEE REPORT

Dr. McGough reported the Rodeo Committee is meeting the second Wednesday of each month. He said also the Rodeo Queen and Court had been selected. Mr. & Mrs. Sam Johnson will be chaperons for the Queen and Court.

RODEO PRIZES

McGough said individual hand tooled leather shaving kits are being ordered for event winners.

SHERIFF'S POSSE

Washington County Sheriff's Posse will drill prior to each Rodeo performance. Passes for entrance into the Fair will be issued to each Posse member and wife.

RODEO TICKET PRICES

Ticket to the rodeo will be \$4, \$3 and \$2. Advance sales and ticket sales to be worked out by the Rodeo Committee with Fair Board approval.

SOUND SYSTEM

The Rodeo Committee recommended one mike and three speakers be purchased.

ARENA DECORATION

Dr. McGough said six Boards selling for \$50 each will be sold to cover shutes. Lighting was mentioned as a problem - the present lighting is very poor. More discussion to take place at the April 4 Board meeting.

COMBOY BREAKFAST

The Washington County Sheriff's Posse will sponsor the Rodeo Cowboy's Breakfast on Saturday, August 4 in Hillsboro between second and third on Main Street.

RODEO TICKETS

No tickets for rodeo admission will be given away. Only Cowboys and Worker's will be issued a special pass by Dr. McGough.

BARBECUE - (RODEO)

August 2, thursday evening a special barbecue will be held for advance rodeo personnel, rodeo committee, Queen and Court, Fair Board and Special guests.

RODEO CONCESSIONS & PROGRAM SALES

The Active 20/30 Club will be asked to sell concessions and Rcdeo Programs on a % basis.

WATER TAPS

Mr. Adams requested that we install several water taps on the South End of the Fair Grounds.
