Fair Board Chairman Jerry Boyer welcomed the guests, asked them to sign names on the guest list and declared the meeting open for questions after each speaker on the agenda.

JOHN LEFFEL 7:31 p.m.

Mr. Leffel asked the Fair Board to consider allowing the Tri-County Lambshow, Livestock Assn., and auction committee use of the scales on the fairgrounds. The weigh-ins are a prerequirement of animals being sold at the fair. Mr. Leffel was asked to check with the Fair Office March 16th for an answer.

LARRY MARKUS 7:33 p.m.

Mr. Markus, Northwest Mountain Cruisers representative, gave the club's full support in favor of keeping the fairgrounds at the present location, felt it was feasible for this county with some improvements made, and wished the fairgrounds be reopened to paying customers. They can relate to the Fair Board's frustration. of trying to keep the fairgrounds going on an inadequate budget. The club encourages the Fair Board to inform the Washington County people of the total picture, one that relates to management of economics and one that provides the total utilization of a year-around activity center. By closing the fairgrounds we could lose total commitment from the community to support a positive proposal to keep the fairgrounds open and available.

The club asked the Fair Board for use of the fairgrounds the eve of March 31st for set-up of their show April 1st.

Jim Springer stated that in the past usage of the fairgrounds has included a set-up and take-down time alloted. Apparently this fact had been overlooked.

MOTION: MOVED BY JIM SPRINGER, SECONDED BY CHARLES COLEGROVE TO SUPPORT LARRY MARKUS' PETITION FOR SET-UP TIME THE EVE OF MARCH 31st FOR THE NORTHWEST MOUNTAIN CRUISER CLUB. MOTION CARRIED

7:39 p.m.

STAN SALISBURY Stan Salisbury introduced 1977 chairman of Hillsboro Happy Days and member of Hillsboro Jaycees, Al Young.

> The Board was asked by Mr. Young to reconsider the fairgrounds not being used by outsider groups and that the groups be considered on an individual basis.

The Hillsboro Jaycees proposal for Happy Days use of the fairgrounds was presented to the Fair Board.

AL YOUNG CONT. What the Hillsboro Jaycees will do'

*Clean up Exhibition Building

*Clean up the Floral Area

*Clean up the Arena & Concession Area (if used)

*Clean the 4-H & Exp Building & Restrooms

*Clean the tables & benches (that we use)

*Pay for all the electricity except \$100.00 per month

*Pay for the garbage service

*We will pay for the paper products used

*\$500.00 for expense incurred for the time and items consumed such as light bulbs, water, etc. and for time attributed to salaried Fair Employees

*\$1,750.00 for Saturday, June 22nd - July 9th

Mr. Young said the Jaycees could secure the use of the Armory because the fairgrounds is no longer using it and run an event compatible with the Fair, i.e., swap meet, bingo.

Ralph Holland questioned the use of the armory the Jaycees intended and if access to the armory would be allowed by the Fair Board.

Mr. Springer related that by State law, Chapter 565, 565.610 the Fair Board can control the use of the armory for two days prior and two days subsequent to the County Fair. Therefore, the Jaycees need not be concerned about armory usage conflicting with the Fair.

Mr. Boyer and Mr. Young attended a morning meeting organized by the Hillsboro Chamber of Commerce of all the service clubs in the area March 15th. Mr. Young discussed facts that two uses and concerns should be directed toward the fairgrounds, (1) 4-H and all agric tural interests in the county and (2) fairground usage as a multi-purpose off-season facility. The two areas must be clearly defined and mutually beneficial - the basis of the two uses and spelled out.

The Fair Board agreed to take the Hillsboro Happy Days proposal under advisement. The fairgrounds presently remains closed because of lack of operating funds and community input is much needed to reveal county feeling. The Happy Days proposal is also a lower dollar figure than last year,

Mr. Young felt that the fairgrounds management was not expending an extra manpower and dollar effort of any appreciable amount to ready the fairgrounds for Fair after their use.

Fair Manager estimated a cost of at least \$2,000 over and above regular budget, because of the short period of time between the two event, i.e., manpower must be increased to prepare the fair-grounds for the County Fair. And, of course, the fee paid by Happy Days for grounds usage does not represent full reimbursement of cost to Fair Board.

AL YOUNG CONT. Bill Kubler, Active 20/30 Blub, questioned if \$2,000 figure was a fixed or variable expense over and above fair budget.

Chairman Boyer expleained that because the County Fair preparation had to be 'last minute' to put in the proper facilities the figure was over and above regular expense.

Mr. Springer commented at least on advisory personnel and seven extra people had to be hired last year.

A decision will be given the Happy Days committee in seven days or March 22. A meeting to decide the proposals for fairgrounds usage was set for March 22 at 8:00 p.m.

DOUG VAN DYKE 8:06 p.m.

Doug Van Dyke, Terra Trackers 4x 4 Club, introduced Mark Cardner Oregon State Representataive for Hillsboro. Mr. Gardner, after attending the Oregon Fairs Assn. convention, felt that it would be possible for him to work for legislation to reapportion the distribution of State funds for more support of the Fair. He felt the closing of the fairgrounds was drastic and speaking for the Terra Trackers, wanted the Fair Board to know they were relying on a verbal commitment for use of the fairgrounds. A contract had not been signed, because fair management had been too busy. Trophies, insurance, and advertising had been ordered.

Terra Trackers requires usage Saturday and Sunday May 27 and 28. There is no other play day spot for that weekend. Mr.Holland was told that people attend from Washington, Oregon and Idaho. This would be the fifth year they have used this location. It is a non-profit organization and contributes monies to charity. Mr. Colegrove was informed that the initial contact had been made in late fall and in January, 1978.

Mr. Boyer said the matter would be taken under advisement and at the March 22 meeting a decision will be made. A copy of the Fair Board meeting agendas will be sent to Mark Gardner, per his request.

Gordon Scott commented that in the past the club has not cost the Fair Board any out of the pocket expense and in fact has grated the gravel roads at the end of their function.

Virgil Markus indicated that four wheel drive shows are important in that they return proceeds to the community in support of charities. Approximately \$50,000 was donated last year.

Chairman Boyer pointed to the fact that the fairgrounds, too, is a non-profit organization and gets no donations. Why are the fairgrounds taken for granted? DOWG VAN DYKE The was agreed that people should be made aware of the non-profit CONT. Estuation and become involved in the support of the fair.

SONJA SIMPSON 4 H Chairperson Sonja Simpson presented a list of considerations 8:21 p.m. to the Fair Board to keep lines of communication open.

- * As 4-H is a federal department it is unable to support the Fair. However, 4-H members, as private citizens, con do whatever they deem necessary.
- * It was rumored that 4-H must obtain its own insurance coverage. The Fair Board instructed that the insurance coverage is and will be provided by the Board.
- * Does the Board of County Commissioners have the fairgrounds sold? 4-H is concerned about the Chuck Wagon, and Ranit/Poultry building. A task force appointed by the Fair Board comprised of 4-H, open class exhibitors solicited improvements for the Rabbit/Poultry building the Fair Board constructed in 1977. If sold, the 4-H would like to be considered in the salvage or reimbursement.
- The audience expressed concern about the rumor of a sale. The Fair Board unanimously opposes the sale of the Washington County Fairgrounds. If it were sold it is felt that the County should have a moral responsibility to provide funds for relocation of the fair. However, at this time, there are no indications that those funds are earmarked in this way.
 - * Could the 4-H set up a budget committee to allot the 4-H funds as they see necessary, i.e., drop premium money and spend more on ribbons and quality judging.

Jim Springer felt that the fairgrounds was part of 4-H life line. The 4-H children helped build the buildings and taking away of premiums is not the place to trim dollars. 4-Hers have personal expenses and spend many hours on their project. They deserve awards, if they are merited.

Board Chairman asked for 4-H parents in the audience for thier input.

Leonard Luttrell, felt that ribbons were more important then a premium award.

Dene Mallory agreed it was important to kids to see what they will take home. Quality judges are very necessary. The premiums are small.

Agnes DeLashmutt said that the kids go through the Fair book to add up what they will receive and look forward to that time.

Gordon Litner felt that the ribbons and trophies were most important.

Clarence Rice felt that 4-H and Fair helped to make productive citizens. He along with five other grangers represented at this meeting and 4-H parents feel those kids are entitled to a fair.

SONJA SIMPSON CONT.

Warren Luke stated it would be terribly disappointing if the fair closed. Probably 50% for ribbons only and 50% for premiums too. Promeums were welcome to help the out-of-pocket expense.

Don Leitchman thought that all the 4-H kids would gladly donate their premium monies just to keep the fair open.

Bob Fussell asked, if the .0000425 mill, levied by Commissioners without voter approval, monies has been give to the fair.

Fair Board has not received those monies. County has the authority to levy for fair activities, if they want to: The .0000425 mill money must come from dollars County receives and must be within the 6% limitation.

Fair Manager and Joe Evers stated that the Fair Board has been trying to receive those monies for 21 years.

Joe Copening said the County is collecting within the 6% limitation.

Don Copening asks 'Why don't we get it?'

Fair Board agrees those dollars would balance the budget.

Marinus Wolf commented that attendance at the Fair Board meetings would be a good time to exchange ideas between county citizens and Board. Chairman stated time of meetings is in public media and visitors have always been welcome.

Mr. Rice asked what are other Counties doing in the way of dollar support for their fairs. Are those Fair Boards receiving money to operate efficiently and build necessary spaces?

Fair Board answer was yes they are.

Last thought from Mrs. Simpson, are the list of 4-H activities submitted to the Board including the Horse Fair part of the County Fair?

Mr. Springer answered that the reason for a separate 4-H Horse Fair is because of limited space and the large size of the Horse Fair requires it be run several days in advance to make room for the remaining Fair activities.

JOHN LEONARD 8:50 p.m.

John Leonard introduced Ron Weise, who in turn requested the Board to consider his leasing the fairgrounds from December 3 to 23, 1978 for \$2,500 rental fee plus utilities. He would put in approximately 100 booths in the main exhibit building to rent to Oregon arts and crafts people to vend their products.

Mr. Evers pointed out the poor heating and the recreational vehicle use of the building during that time of year.

FON WEISE CONT.

Fair Manager Hesse added that when the rains come, the booth occupants and their wares are going to be very uncomfortable with rain flipping down on ther.

John Leonard had hoped to put together this mant to provide Oregon handmade Christmas gifts for people to purchase here in the county.

Chairman Boyer advised the proposal will be taken under consideration at the meeting on March 22. A decision will probably be made in the next few weeks.

MINUTES APPROVAL MOTION: MOVED BY CHARLES COURGEOUT, SECONDED BY JIM STRENGER TO APPROVE THE MARCH 1st MERTILOS MENUTES AS PRINTED AND MAILED. MOTION CARRIED.

Audience is directed by Chairman Boyer they are welcome to stay, if they have more input.

KEN PRICKETT

For seven years the Active 20/30 Club has used the fairgrounds to hold the annual Haunted Caves. Preparation and even as is held last two weeks in October. Dollars are donated to Childrens Heart Fund. They also have the reader board & i recycle center. Mr. Prickett asked the Fair Board to consider their use of the facility.

The Fair Board agreed to take the matter under advisement. Discussion will continue at the March 22 meeting.

AUDIENCE PARTICIPATION Bob Twigg inquired about the meeting with the Board of County Commissioners. He was informed that the meeting is public and it is the right and duty of those interested in voicing their opinion to come and do so.

Virgil Markus indicated that the NW Mountain Cruisers have dollars alloted toward initiating to circulate a petition to get signatures for a voter approval of a fairground re-election. They need a figure from the Board of cost to run the Fair for five years and make necessary repairs and improvement.

The Board agreed to give the necessary figures for the Club to continue their endeavor. It was felt that the people need to know the hard facts - the fair is in jeopardy.

Mr. Springer commented that a \$325.00 per day amount is needed to operate the fairgrounds today. Do we want to update or be self-sufficient? Input is very much needed from the County citizens, so that the proper steps can be taken. Voters have a voice and must use it.

Ken Prickett wondered how much it does cost to keep the facility as it sits in a useable manner. He commented that the .0000425 mill should be alloted to the fair and if not, why not?

Al Young asked Mark Gardner if the people can mandate through a referendum the 6% limitation spending - Can we tell the County Commissioners how to spend those dollars?

AUDIENCE

Mr. Gardner answered the people cannot bind the County Commise-PARTICIPATION foners in that way. However, the State can tell the County how to spend those monies.

> Mrs. Clarence Rice felt that many people were not well informed of the issues at the polls. The new multi-purpose building frightened poeple away. People read the ballot in voters booths and were not prepared to vote. Parhaps had it been a measure for drainage and repairs to buildings only, the substitute could have been affirmatively considered on the spot in their voters booth and passed. She requested that better information and education of voters be provided, especially in the eastern part of the county, where they are overshalowed with Mulimomah County Effairs.

> It was agreed that if nothing else, voters must realize the gravity of the fairgrounds situation and be given the options they have to consider in clear and concise facts. Of course, voter education is a monumental task, but must be faced with positive action. All interested in saving the fair must become involved.

The Fair Manager and Fair Board was invited along with anyone else interested to come to the Granger meeting March 313% at Oddfellows Hall - 7:30 p.m. to talk about saving the fair.

Larry Markus said that the .0000425 mill, of course, is not near enough to bring the deteriorating building into shape.

Ron Weise asked where are the 1,700 grangers and 2,000 to 3,000 4-H members, families and leaders? Let them be heard.

Mr. Boyer stated that because of the bad condition of the facility, it is now time to play catch up.

Leonard Luttrell was not in favor of the convention center because the idea of making it pay didn't seem realistic.

Agnes DeLashmutt was advised that the signatures on the petitions were not due at the April 5 meeting with the Board of County Commissioners. Mr. Boyer added that approximately 4,500 signatures are needed as 10% cannot be validated. July 7th is the petition filing date. Letters can be placed on file now with the Fair Board or Board of County Commissioners as to voter opinions.

Larry Markus stated there will be a meeting to prepare for proposal presentation April 5th. The meeting is March 28, Tuesday, 7:30 p.m. at the fairgrounds.

Jim Springer requested a 10 minute recess.

RECONVENED MEETING Chairman Boyer reconvened meeting in main exhibit building at 9:32. Because of the cold temperature in the building, it was decided to move to the smaller fair office.

At 9:38 meeting was brought back to order.

MOTION: MOVED BY JIM SPRINGER AND SECONDED BY JOE EVERS TO ALLOW THE WASHINGTON COUNTY MENTAL HEALTH PROGRAM A SINGLE SATURDAY PRODUCTION IN THE STAGE AREA WITHIN THE FAIR MANAGER'S SCHEDULE OF EVENTS TIME FRAME. MOTION CARRIED.

USE OF FAIR-GROUNDS

The Community Garden project will have to be considered at a later meeting. The International Timber Fair was booked into Clackamas County Fairgrounds.

FRED MEYER MEETING

Jim Springer and Ken Lewis, Rodeo Chairman, met with the Senior Advertising man for Fred Meyer. Fred Meyer would like to sponsor the rodeo and fair. They would advertise entire fair and rodeo dates with their day in darker figures; they would give discount tickets to be turned in at fair gate; the advertising would be in all newspapers including Oregonian, Valley Times, etc., the public address would announce the fair activities every ½ hour for shopper interest in Fred Meyer.

FRED MEYER MEETING CONT. A meeting is scheduled to again discuss the possiblity of Fred Meyer sponsorship. A Fair Roard member or manager and Ken Lewis will be present. Friday would by a day to consider along with a 7:00 p.m. cut-off time for coupon validating.

CHUCKWAGON

The Chuckwagon utility fee is to be charged for fiscal was: July 1, 1978-79.

EXPO FUND

Fair Board recognizes Horse funds are in the account and thing direction as to how the fund shall be 'spent.

FEBRUARY

FINANCIAL RE-CAP

Mr. Springer advised Larry Markus that in the past the Fair Board has put up personal financial statements for operation of the fairgrounds. This Fair Board will not do that. Fair must stand on its own.

4-H FATR USAGE MOTION: RALPH HOLLAND MOVED AND JIM SPRINGER SECONDED TO ALLOW REGULAR 4-H, FFA PREFAIR USAGE OF THE WASHINGTON COUNTY FAIR-GROUNDS UP TO AND INCLUDING THE FAIR DATES. MOTION CARRIED.


