RABBIT-POULTRY BUILDING Jossy reported he ordered drawings (blueprints) from Fred VanDomelen. The next step will be to obtain a building permit from City of Hillsboro and to get bids for materials and also firm bids from construction companies.

If prices are out of line the Fair Board will hire a carpenter to work with Mr. Mohr and volunteers.

4-H LEADERS BANQUET Mrs. Caroline Cannon, 4-H Home-economics extension agent, has extended to the Fair Board an invitation to attend the 4-H Leaders Banquet scheduled for April 14. The Board will be receiving personal invitations in the mail.

COMMERCIAL PASS SYSTEM Mrs. Hesse sent a written memo on the current commercial pass system with a recommendation to consider a new pass book ticket system. This would eliminate all list and free commercial passes Holland asked about the method that would be used to sell tickets Mrs. Hesse explained only commercial booth persons would be notified that ticket passes are available and then a list with booth number and tickets purchased will be kept so a running audit could be maintained. This should eliminate mass purchase and abuse.

MOTION: MOVED BY RALPH HOLLAND, SECONDED BY JERRY BOYER TO IMPLEMENT THE RECOMMENDED PASS BOOK SYSTEM FOR COMMERCIAL GATE ADMISSION. MOTION CARRIED.

HORSE MEETINGS

Manager Jossy reported being invited by Gary Poole of Washington County Association of Riding Clubs to visit at their March 16 - 8:00 p.m. meeting to be held at the Hillsboro Airport conference room. Boyer and Holland offered to attend also. Boyer reported meeting with 4-H livestock agent, Al Flory, regarding the 4-H horse program. Flory confirmed that 4-H horse championships will be held opening day of the fair (August 2).

EXPO FUNDS

Letter regarding Expo Steering Committee and funds written by Manager Jossy was read to the Fair Board. The Board gave approval to the letter, which will be mailed to all horse oriented groups in the county.

PROPOSED MILK PARLOR

Proposed milk parlor dimensions were presented to the Board by Evers. Overall size - 24' x 28': parlor 24' x 16', dairy wives booth 12' x 12', and milk house 12' x 12'. Jossy will ask the advanced high school drawing class to engineer a detailed drawing, which VanDomelen will then check. This will keep blueprint cost minimal. VanDomelen suggested the Fair Board hire licensed plumber and electrician for hook-ups.

YOUTH TO PARTICIPATE IN OPEN CLASS Evers introduced Merle Peters, representing Purebreed Dairy Cattle Assn., who spoke in favor of allowing 4-H and FFA youth to compete in Open Class dairy provided the animals are registered in the exhibitors name.

Charles Colegrove presented a letter he had requested from Duane Johnson, Extension Specialist 4-H Youth, regarding youth in open class using the same animal. Johnson's letter pointed out the agreement should be made at County level involving 4-H administrators in concert with 4-H members and volunteers and management of open show. He further stated that he did not feel it was in the best interest of the 4-H program. His recommendation is based on the following observations and beliefs. 1. 4-H program objective is based on development of the child such as communication skills, decision making skills, and the skills that may have been obtained in a project area.

YOUTH IN OPEN CLASS (CONT.)

2. fair environment offers an opportunity to develop in areas of cooperation, pride and responsibility; all which lead towards development of a positive self image. 3. He further states that "we believe that the major objective of the open class show is the evaluation of the product with limited concern for the individual". Johnson suggests that if a young person has progressed through the 4-H program to a point that their objective is to measure their products against those of the open class, we would believe that there are two acceptable alternatives: a. exhibit in open class b. 4-H member may exhibit some animals in 4-H and open class. His final point related to receiving dual premiums on a single exhibit at a given show. He stated most Fairs have a difficulenough time making financial ends meet. Much discussion followed on pros and cons and the following motion was made and carried:

MOTION: MOVED BY JERRY BOYER, SECONDED BY RALPH HOLLAND THAT IN THE DATRY DIVISION ONLY THE FAIR BOARD ALLOW 4-H & FFA YOUTH TO MAKE ENTRY IN OPEN CLASS FOR ONE YEAR ON A TRIAL BASIS WITH EVALUATION TO FOLLOW IMMEDIATELY AFTER 1977 FAIR. MOTION CARRIED. Those voting affirmative were Colegrove, Boyer, and Holland. Lone negative vote was cast by Springer.
