The Board has not made public any scheduling of events and could not account for this information.

Mr. Spiesschaiert came to the meeting after the Van Dykes left and apologized for having the wrong information but stated he had read it in a paper so he exceed to go to Yamhill. He would like to work out some type of arrangement so he can participate in Washington. The Board thanked him for attending and will keep in touch with him.

Rental prices on the restaurants was discussed. Fr. Adams moved to increase the rent to \$50.00. Dr. McGough seconded. Motion carried.

He was advised to handle this through the fair office and set up a savings account with receipts being issued and a statement on these receipts to the effect that donations over \$10.00 will be refunded if the building is not built. He was advised by the Board to discuss this with the District Attorney for all legal angles.

Several members of the Historical Society came out and staked off an area southeast of the main Exhibit Building for a Pioneer Center. They would then like the old buildings moved to this area and they would put a worm-rail fence and start plantings, etc. The Board agrred to this.

Fir. Adams moved that the minutes be approved as mailed. Dr. McBough seconded. Motion carried.

Mr. Jossy's term will be expiring on April 23 and a replacement for this position was discussed. Several names were mentioned with the Board agreeing on Don Blem's name to be recommended for consideration.

The Board discussed the possibility of appointing a committee to handle the publicity, etc.

As there was no further business, the meeting was adjounred at 11:10 p.m.
