POLICY ADOPTED

The Board discussed policy and philosophy regarding dessemination of materials during the County Fair.

MOTION. MOVED BY JERRY BOYER, SECONDED BY RALPH HOLLAND TO ADOPT THE FOLLOWING POLICY UNDER ORS. CHAPTER 565.240 WITH CONCURRENCE OF COUNTY COUNSEL. MOTION CARRIED.

POLICY

Pursuant to authority vested by law in the State of Oregon under Fairs and Exhibits, the following regulation is promulgated to effect the administration and enforcement of OES Chapter 565.240:

No advertising, canvassing or soliciting, and no dissemination of written materials, for political or religious purposes is permitted on the Fair parking lot and on other property of the Washington County Fair outside the fenced-in portions of the Washington County Fairgrounds. Such activities must be conducted in accordance with the following conditions:

- (1) Parking lot entrances, exits and travel lanes must not be obstructed. Interference with traffic flow and with the duties of traffic attendants is prohibited.
- (2) The use of land vehicles is prohibited, except that non-commercial advertisements securely attached to the body of the land vehicle are permitted. Use of air vehicles is prohibited. Use of land vehicles as platforms or other temporary or permanent structures or platforms is prohibited.
- (3) A person conducting such activity shall not place pamphlets, leaflets or other material in or on vehicles without consent of the driver or owner of the vehicle. Such activity must be conducted with pedestrians only, after vehicles have been parked and exited.

- (4) Loudspeakers and other sound devices are prohibited.
- (5) Activity causing a crowd to gather is prohibited if pedestrian or vehicular traffic is obstructed or impeded.
- (6) Activity conducted within fifty feet of an admission gate or ticket booth is prohibited.
- (7) Active obstruction of a Fair visitor's line of travel or active detention of a Fair visitor against his will is prohibited.
- (8) Abusive language and actual or threatened physical harm directed against a Fair visitor is prohibited.

This policy shall become available upon request at Washington County Fair, P. O. Box 115, Hillsboro, Oregon 97123.

Application for proposed multi-purpose building to be located on the fairgrounds is still on application in Seattle. Second round will commence on June 15, 1977. Grants remain at 100%.
