PORT OF PORTLAND

County Right-of-Way Coordinator Tom Spear was scheduled to attend to discuss easement for 34th Avenue as proposed by the Port of Portland. The Port did not send additional information as promised, so Spear did not attend the meeting.

CONSENT AGENDA

MOTION: MOVED BY HOMER SPEER, SECONDED BY JEANNE LEESON TO APPROVE THE BILLS AS SUBMITTED, THE MARCH 1984 FINANCIAL RECAP, THE APRIL 4, 1984, BOARD MINUTES, AND THE MARCH 1984 OFF-SEASON USE CALENDAR. MOTION CARRIED. (Bills listed on page 2.)

4-H

The Fair Board noted an appreciation letter from Extension Agent Caroline Cannon and Hesse's farewell letter to her. Cannon is taking a new position in Multnomah County. Leeson asked what effect the 4-H personnel change will have on the upcoming fair. Baron responded if an experienced 4-H agent is hired, it will take a year for the agent to become familiar with Washington County. If the agent is new to 4-H, it may take up to two years to become familiar.

In regard to Lyle Spiesschaert's employment, Baron recommended the Fair Board not become involved in an O.S.U. personnel matter.

COUNTY COUNSEL

Assistant County Counsel Dan Olsen has been assigned as lead counsel for the Fair Board. Olsen will attend the June 6 Fair Board meeting to become acquainted with the Board's functions and needs.

ZONE CHANGE

County Senior Planner Nancy Gordinier drafted a work program for the proposed 13.4 acre plan amendment and zone change. The Fair Board will be paying the required fees. Hesse feels the work schedule is a good one.

ENTERTAIN-MENT

Chris Cullen has been hired as Special Events Coordinator for 1984, and she has begun scheduling entertainment for the fair. Several weeks ago Johnny Limbo and the Lugnuts cancelled their concert at the fair to be in Las Vegas, but a few days ago the Lugnuts called saying they will be available to play the fair. Hesse scheduled them for Saturday evening. In the meantime Hesse had signed a contract with the Wray Brothers Band for two Thursday evening performances. Washington Federal Savings Bank will still be sponsoring the Lugnuts.

CHAMBER

The Hillsboro Chamber of Commerce is producing a video tape to promote the City of Hillsboro. Cost of production is \$7,362, and emphasis will be placed on some available commercial property and the city's livability. The 13.4 acres of fairgrounds commercial property will be included in the video tape. Leeson felt the price for production of the tape was too high.

MOTION: MOVED BY HOMER SPEER, SECONDED BY JEANNE LEESON TO APPROVE A \$50 CONTRIBUTION TO THE HILLSBORO CHAMBER OF COMMERCE PRODUCTION OF A VIDEO TAPE TO SELL HILLSBORO; THE FAIRGROUNDS COMMERCIAL PROPERTY TO BE INCLUDED IN THE TAPE. MOTION CARRIED.

ATTORNEY GENERAL The Board briefly discussed 1976 Attorney General's opinion on the relationship of the county commission to the county Fair Board regarding use, vacation of property, disposition, relocation of the fairgrounds, and the need for inclusion in the operating budget of money held in a sinking fund. The Fair Board suggested Hesse forward the opinion to County Counsel.

FAIR & The Fair & Rodeo Court coronation dance was successful and profitable. Leeson RODEO COURT went to take pictures for publicity.

TASK FORCE The Fairgrounds Development Task Force has been assembled. The next step is to set up a meeting date and time. Speer will give an orientation on the fair-grounds master plan. Hesse has forwarded to the Task Froce the master plan, Ordinance 288, and the "fairgrounds commercial" zone.

SECRETARY Valerie Bentley will be leaving Fair Board employment after the fair, and Hesse is interviewing to fill the Administrative Secretary position. The new person should be on board the middle of May.

ADVERTISING The Fair will be participating in the "Entertainment '85" booklet with a two for one adult admission to the 1985 fair.

URANCE

Hesse recently met with the County's insurance company to get specifics on liability and fire insurance on the fairgrounds. There is no coverage for loss of livestock; a hold harmless is printed in the premium book. Hesse said it is not unusual to cover only the buildings against damage. The Fair Board could purchase a policy to cover the livestock. The Leonard Adams Co. will be back in touch with price quotes on livestock coverage, so the Fair Board can make a decision as to whether or not they wish to carry insurance.

There are "no smoking" signs and fire extinguishers in most buildings. The insurance company suggested each event on the fairgrounds should provide a separate insurance policy. Hesse said half the events would not be able to afford to use the fairgrounds if that were enforced. The insurance company will check into economic policies or not enforce the ruling.

OFA

The Fair Board agreed to nominate Margaret Fry for the 1984 OFA Distinguished Service Award.

JAYCEES

The Jaycees are interested in setting up booths on the fairgrounds to sell class 3 fireworks during the Happy Days; one booth in the parking lot and one near the Sheriff's Building. The fireworks are ignited by matches. The Board agreed the risk was too high with the straw in the barns and dry grass in the parking lots, and the clean up too great a task.

MOTION: MOVED BY JEANNE LEESON, SECONDED BY JOHN LOVE NOT TO ALLOW FIREWORKS TO BE SOLD ON THE FAIRGROUNDS. MOTION CARRIED.

AATIONS SUPT.

McAuley reported he is taking bids for the plumbing to update the Cloverleaf Community Building kitchen, and the cabinets will be ordered soon. Plumbing is running \$1,200 to \$1,700.

The Fair Board agreed to request the increase in the hotel/motel tax and work with WCVA for passage. The fairgrounds needs an on going source of revenue in view of the \$2 million shortfall to implement the fairgrounds development plan.

MOTION: MOVED BY HOMER SPEER, SECONDED BY LLOYD BARON TO SUPPORT A 2% INCREASE IN THE HOTEL/MOTEL TAX -- 1% TO FAIRGROUNDS -- AND TO WORK WITH WCVA FOR PASSAGE OF SUCH. MOTION CARRIED.

DERBY

Hesse reminded the Board about helping out at the July 4 and September 8 destruction derbies.

NEXT MEETING The next regular meeting of the Fair Board will be Wednesday, June 6, 1984, at 4:30 p.m. in the fairgrounds office.
