FAIR BOARD MEETING.

NOVEMBER 30, 1935.

The Washington County Fair Board met in the Chamber of Commerce rooms Friday afternoon, 2:00 o'clock, November 30, 1935, with all members of the board present, President Banks presiding. There were also nine representatives from the different Granges present, and from the Farmers' Union locals.

The minutes of the last meeting were read and approved as read.

The attached resolutions were read from the Hillsboro Grange and from the Washington Grange, and members present said the same resolutions were passed by Pomona Grange. These resolutions asked that the 1932 cash premium rates be used for the Grange booths for the 1935 fair, and that a judge be secured from outside Washington County to score the booths according to certain points, or to award the prizes.

Moved by Hesse, seconded by Minton, that the fair board work out a system of scoring the booths, and giving them 1st, 2nd, 3rd, etc., down the line, and get a judge from outside of Washington County. Motion carried.

Moved by Minton, seconded by Hornecker, that there be no distinction between the grange booths and those of the farmers' union locals, that they be judged as a whole, with the understanding that the farmers' union put in local booths. Motion carried.

The representatives then left and the boatd continued their meeting with Mr. Kraus, county school superintendent present. A bill was presented from the Portland General Electric Company for the use of the transformer in the amount of \$18.47, and from Mrs. Moore for her services as secretary in the amount of \$2.00, and \$.55 for stamps. Moved by Minton, and seconded by Hesse, that these bills be allowed. Motion carried.

Mr. Kraus then made a request of the fair board that they allow the band something further on their expenses during the 1934 fair. He said that in all they were out something like \$90.00. Mr. Minton explained the contract of the fair board and the band to Mr. Kraus in detail, and said that they had donated \$25.00 to the band besides paying for the services of a janitor for the auditorium during the fair, and that the board had no funds to do anything further than what had been done.

No further business appearing the board adjourned.
