Minutes of The Regular Meeting -- November 6, 1974

CALL TO ORDER AND ATTENDANCE Chairman Springer called the regular monthly meeting to order at 8:00 p.m. at the Fair Office with the following Board and Guests in attendance:

BIDS OPENED FOR RAZING OLD BARN

Mrs. Hesse read bids sent to the Fair Board to raze and clean up the old barn. Those sending bids included: Cadet Program of Hillsboro, R.G.R. Inc., T & G Construction, Don H. Pearson, Jr., Ray VanDeMoortele, Terra West Co., International Mining & Trade Ltd., and Ted Garrison.

Highest bid was received from the Hillsboro Cadet Program. Mr. Dagoberg, representing the group said much volunteer work was being injected into the project to help the group secure radios, uniforms, etc. Insurance will be provided. Detective Bruce Minter of the City of Hillsboro also said the area would receive extra patrol while the dismantling was taking place.

MOTION. MOVED BY RALPH HOLLAND, SECONDED BY JOE VANDYKE TO ACCEPT THE BID FROM THE HILLSBORO CADET PROGRAM FOR \$800.00 (flat fee) TO RAZE AND CLEAN UP THE OLD BARN. INSURANCE WILL BE PROVIDED BY THE GROUP, WITH JOB COMPLETION BEING APRIL 1, 1975. M.C.

EXPO TIME CERTIFICATE Jossy said the Bank has notified the Fair Board the Expo Center Time Certificate will expire November 8, 1974. The Board said they would like the money scinvested in the same manner as it previously was.

APPOINTMENT OF JEROME BOYER

Mrs. Cindy Burns, Assistant County Administrator called Mrs. Hesse and informed her that Jerome Boyer has been appointed to fill the vacancy which resulted from the resignation of K. L. McGough. Term will expire December 31, 1974. According to the present records on file at the Courthouse, Mrs. Burns said all the Board's terms expire in one year. This is incorrect and Mrs. Hesse will attempt to help Mrs. Burns correct the records at the Courthouse November 12.

1975 FAIR ENTERTAINMENT Entertainment for the 1975 Fair was discussed. Joe VanDyke indicated that he was interested in having local high school bands perform at the Fair. Majority of the Board agreed it was almost impossible to assemble bands for summer performances. Discussion then revolved around gate admission, family tickets: changing rodeo to Thursday and Friday, and having other entertainment for Tuesday, Wednesday and Saturday.
