The regular monthly meeting of the Washington County Fair Board was held in the fair office on October 1, 1969 with Chairman Jossy presiding. Those present were Lindow, Gardner, McGough, Adams, Ball and Shearer.

Mr. Bob Radkey and Bob Graham attended the meeting representing C.B. and Ham radio operators. They would like to rent the grounds for three days next June to hold a trade fair. They expect a maximum of 5000 people for the three day event. They requested the main exhibit building, a portion of the grounds. beer garden and parking area. Theywould have an admission gate, sell booths to dealers, concessions and beer garden. All proceeds wild go to a charitable organization, possibly the Aloha Retraded School. The Board advised them to proceed with their plans and to come to the next meeting with definite dates desired and at that time a contract will be ready and information on needed insurance available.

Rev. Andrews and Carl Hill, representing the Beaverton Assembly of God Church met with the Board to discuss having a western-type religious festival. All Assembly of God churches in the county will sponsor this event. They would like the south end of the Main Exhibit Building for the night of November 1. They expect 200 to 500 people, with local groups from the various churches supplying the entertainment. The Board agreed to allow this use with the rental charge of \$25.00 plus utilities and \$10.00 for our man to oversee the placing of the bleachers.

The rodeo financial report was discussed. Mr. Gardner moved all rodeo accounting be done through the fair books, closing the special account they have at the Forest Grove bank. Dr. McGough seconded. Motion carried.

Additing barn space was discussed. Mr. Adams meported portable box stalls can be rented for \$18.00 a show. The Board agreed to contact John Leffle and have him present the plan he had for extending a barn from the present swine barn and make a livestock office in the area. Livestock entry fees were discussed. The Board feltthese could be raised and will establish fees before the premium book is printed.

Mr. Bob Ganger contacted a Board member about putting on the Touch and See next year. Mr. Lindow moved a letter be written to Mr. Ganager inviting him to put on a show at the 1970 fair. Dr. McGough seconded. Motion carried.

Mr. Gardner moved the minutes be approved as mailed. Dr. McGough seconded. Motion carried.

The Board was asked to consier names for this committee with appointments to be made at the next meeting.
