KIRKLAND RESIGNATION

Bob Kirkland was given the floor to give an explanation of several sets of tickets that had been turned into the office. Kirkland said he felt that his resignation was asked for because of a personal conflict with a Board Nember.

Holland said that he: is interested in changing the complexion of the total rodeo board. Boyer echoed that the rodeo board must learn to support the fair in totality not just the rodeo. All facades of the fair . must be supported. The rodeo board must serve in the spirit of cooperation and answer to what kind of fair the Fair Board and Management designate. VanDyke said in defense of Kirkland that on numerous occasions, Kirkland has served excellent in running the inside rodeo gate. Boyer told Kirkland that this was not direct criticism of the work he had performed, but perhaps a change is in order. Springer said that the problem on giving out passes may need some adjustment. Jossy asked Kirkland what he felt could be done to pull the rodeo board and the Fair Board together. Kirkland said he felt that in the past the two groups may not have been close, but the trend has been reversed in the past year.
