Chairperson Kathy Christy called the meeting to order at 3:37 PM. She welcomed the guests and staff and called for additions to the agenda.

1) **Consent Agenda:** The Chair requested the two items under New Business be addressed with item A deleted and B (the review of the Fair) moved to Old Business as C.

Budget Overview: The financials/budget overview was presented with the explanation, not all of the charges had been placed in the right line items. Barbara stated it appeared many items had been allocated to incorrect areas and although it would not affect the bottom line some categories would be skewed. Leah commented, she had been working with Melissa to correct the errors. In *Miscellaneous Income* the \$4000.00 donation from Amusement Consulting was questioned. Lisa and Barbara answered that was the fee paid for the grounds for the Fourth of July celebration and should not show as a donation. It had been credited to the wrong area. Rich questioned the ATM reporting. Discussion followed concerning the need for a separate line item for the ATM transactions. Line items in 182 (Miscellaneous) were questioned. Barbara reported two short time employees had been paid "out of category" by Melissa with the explanation it had always
