September 4, 1968 Fairgrounds

The meeting was called to order by Chairman Gardner at 8:10 p.m.

Mr. Jossy moved that the reading of the minutes be dispensed with. Mr. Holt seconded. Motion carried.

Harold Baseler, Bob Donaldson and Gary Baker attended the meeting as representatives of the Jaycees. They are interested in helping the Board arrange for bringing the sewer closer to the grounds so it can be utilized. It is now up to Brodgen on 28th and will be on Hyde and Russell on the SW side of the road across from the parking lot. Mr. Gardner appointed Mr. Holt, Mr. Donaldson and Sam Kyle as members of a sanitation committee to study all angles of dtaining this service to the grounds. Teh reason the Jaycees are helping is that the sanitation department informed them they could not operate happy days here on the grounds again unless other sewage disposal is availabe. The committee will report at the next regular board meeting.

The Jaycees presented the Board with two checks in the amount of \$992.59 for use of the grounds during Happy Days.

Two representatives of the Quarter Midget Association met with the Board to discuss the possibility of using the track for more races. They reported the track was well received by the racers and it has caused much interest in the area and they are considering organizing a club in Hillsboro. Since the Board charges rent on any use of the grounds they have no way of obtaining money since their organization has rules forbidding them to charge admission. The entry fees from the drivers buys the trophies and pays other small costs. This track would be used only for Bids between the ages of 4½ and 16. Mr. Jossy moved thatthe Board allow this usage for the following year, rent free, and the Fair Board retain concession rights and parking fee rights. Dr. McGough seconded. Motion carried.

Three representatives of the Rodeo Committee, Bob and Joan Brown and Bill Rogers, met with the board to report on the rodeo. All figures are not final but a check in the amount of \$3200.00 was turned over to the Board. Many items were discussed and will brought before the Board in letter form from the Committee when all is finalized. Mr. Brown asked that the Board change the dates in the Rodeo Committee organization outline when the appointments are to be made from Jan. 1 to October 1. Mr. Brown informed the Board there are several meetings and convention before the first of the year that all members should attend. The Board approved this change and appointments will be made at the next board meeting. Mr. Brown also asked that the Board talk to each prospective committeeman and inform him of his duties before making an appointment so that they will know what is expected of them.

Thank you letters are to be written to Norm Bernbeck, MacKenzie Motors and the Washing ton County Livestock Association.

Mr. Holt reported on the insurance coverage. He met with Mr. Milbrodt and Mr. Luetwyler about the accidents on the bucking barrel and they informed him this will be taken care of and the Board will not be responsible personally for any liability. They will furnish the Board with a complete insurance covering policy for the files.

Mr. Holt moved that the Beard authorize Mr. Ball to have the Green Thumb crew erect a good permanent fence on the east side of the grounds. Mr. Lindow seconded. Motion carrieds.

Correspondence was read from Goodwill Industries, Mrs. G. W. Kurtz, Victor Atéhey, and JoAnn Burton. Mrs. Burton informed the Board she would have to resign as superintendent of the Poultry department. The Board asked that the secretary write Mrs. Burton a letter regretting this discussion and including a Lifetime Pass for a job well done.

The Board approved a Lifetime pass for J. B. Thomas, former FFA instructor.

Mr. Holt presented the following:

Stock Barns and Show rings:

- 1. Request that speakers be installed in all dairy sheep and hog barns from show ring PA system.
 - Another light and pole be erected between north and center show rings.
 - Request that outlets on posts be independent # of all lights.
- Washing facilities requested by each section of barns. none by open class 4. barn.
- New tie poles requested at each barn and prohibit tieing to fence. 5.
- 6. 4th show ring requested east of present show rings and north of open class. Should be suitable size to accommodate bleachers inside ring and still have 15 foot circle in cneter.
 - 7. OPen stock barn needs bamboo awning or shade on west side.
- 8. Wooden grated platforms by each watering faucet to eliminate muddy water hole by each.
 - 9. Prohibit decorating lights or greenery in stock barns due to danger of fire.
- 10. Paint all bleacher seats. Footboards not necessry but would preserve boards.

Armory -

1. Do teen dances pay off? They keep these teenagers from the fair.

Rodeo Grounds -

- 1. New and small flag pole urgently needed.
- 2. Care of arena floor left entirely to Ed Ball with no interference from Rodeo
- 3. I don't feel the sewer drainage truck should be used to sprinkle the arena and roads.

Fair Sign Board -

1. Does Board want Washington County spelled out in two foot sign on top with Fair and Rodeo in one foot sign below this? This should leave sufficient room for events below.

Other signs -

1. Ken Dykeman of Hank Signs wants to paint signs for all of the buildings, etc. He believes that with better signs we could not only personalize the grounds better, but also add some class to the Fair itself. He intimated that he would be interested in painting the signs needed at a very reasonable rate and collect for some over a long period.

General Fair Business =

- Teh cost of exhibit space should be higher and public educated as to the advantages of placing a booth at the Fair.
- A thorough study should be made of all the facilities and the rentals for same should be up graded to attempt to put the facilities on more of a self-paying
- 3. Further study should be made as to the needs of and the possibilities of a care-taker of the grounds and a fair manager. These both could be realized by up-grading the rental fees and getting rents from everyone that uses the facilities

4. A gate is suggested for the north entrace and if necessary a whole new sat of locks and keys issued to control the traffic onto the fairgrounds.

Mr. Ball asked the Boards desirex on boat and trailer storage. The Board approved this with rental of \$25.00 for the season or \$5.00 a month. The dead storage season from O tober to May 1st.

The 11th was set for the luncheon meeting.
