Pairgrounds September 6, 1967

The meeting was called to order by Chairman Gardner at 8:20 p.m.

Minutes of the previous meeting dispensed.

Mr. Weaver Clark met with the Board to discuss the problems arising from Mr. Sponhour renting the barn. He received a letter feom Mr. Spoonhour stating we was to move he materials he has had stored withing the next 30 days, and also pay rent of \$25.00 per month. Since the rent on the barn is only \$10.00 per month, herelt the arrangement was out of order and requested the Board to look into this. He has stored materials in the barn for years and when the fair first moved out here, he moved the grass for the rent. He was not contacted in regard to renting the barn until M. Spoonhour had already rented it and he was told to move. The Board stated they would meet with Mr. Spoonhour and Mr. Clark to write Mr. Spoonhour.

Mrs. Barbara Jackson met with the Board to discuss problems during the Open Class horses at halter. Ribbons were stolen from the box stalls and she felt there should be a barn superintendent on duty at all times with several children to help. After hearing her other complaints, the board asked that she write a letter stating these and making recommendations so that this may be passed on to the Horse Superintendent for the 1968 Fairi

MR. Bob Symank presented his final bill for the rodeo facilities. The toal cost of the building was \$8,335.39. This was \$510.39 above the original bid and the additional cost was due to the additions made that were not on the plans such as the holding pens and increased sizes of posts, etc. Mr. Lindow made a motion that the balance of \$2,335.39 be paid Mr. Symank. Mr. Weible seconded. Motion carried.

Mr. Jan Gumprecht and Mr. Vern Atwood attended the meeting and reported on the 4-H portion of the fair. Miss Gumprecht stated there was confusion caused during the style revue due to the dance. Several parents complained to her about this and she asked that this be considered next year. The Board apologized for this and explained that the problem came with Ross Hart having to leaver during the fair. If the 4-H building could be completed, this would be the ideal place for the style revue? and that would leave the Armory for a dance or other acitivities.

Mr. Atwood asked if the Dog Obedience could be held in the Armory. The heat was hard on all animals and exhibitors and the Board felt there is no remedy for this uless there was dovered show rings. Possibly this could be moved to a night acitvity. He also said there was too little room for the office staff and not enough horse stalls. No action taken.

The possibility of covering the æea between the two sheep barns to make a covered show ring was discussed.

m Mr.}$ Weible asked if 2 sections of bleachers could be erected for the jumior rode Sunday.

M_r. Bob Brown attended the meeting with a few suggestions concerning the arena. He asked the Board to consider having calves left at the arena area during the summer months as there is much interest in practice roping. There are several sections of the rodeo plant that should be strenghtened, the gates should be blocked up and chained shut so that they will not be left hanging to sag out of shape, and the wood needs a coat of paint or preservative. Mr. Ball will investigate the cost of putting on some type of paint on theplant.

The Active club requested the concession stand at the grandstand for next year. The Board had discussed operating this. Since there is plenty of time before the contracts are sent out, this was tabled for a later date.

Changing the dates for the 1968 fair was discussed. Mr. Lindow made a motion that

the dates be kept as tentatively set for August 13 through the 17th. Mr. Jossy; seconded. Motion carried. Raving a four day fair was discussed. The 4-H will work over their schedule and see if this could be workabe.

The covered grandstand at the high school was given to the Board. Mr. Ball met with a house mover and the bid for moving it to the grounds was \$500.00. Additional costs would be the concrete footings and having the power and phone companies on hand during the moving. The Board felt this would make the cost prohibitive and asked that Mr. Jossy take this information to the school board.

 $\rm M_{\rm K}\bullet$ Jay Callendar would like to put on a dance for the benefit of the 4-H building. This was discussed and Mr. Gardner will meet with the Leaders Association to get their feelings on it.

Mr. Callendar would also like to put on a teen-age production during the fair next year. TAbled for furthee date.

Mr. Ball was approached about a full-time manager position. He stated he would think about ft and let the board know the first of the year.

The luncheon was set for the 13th at the Dinette.
