FALL MARKET

Addy Hesse reported that to date there are 18 paid participants in the Saturday Fall Market scheduled for September 10. ZONING REPORT

Addy Hesse reported on the meeting with Larry Derr and Jim Ewert about rezoning the Fairgrounds. The Fair Board wishes to go for a complete zone change from residential to commercial. The condition by the city is that the Board construct some kind of noise buffer on the South end of the grounds, as there have been some complaints by residents in that area. The Fair Board feels that this should be a joint effort with the City because the city is leasing the South end for ball fields, etc. At this time, the Fair Board cannot book any events that have not taken place historically. Fair Board will review the zoning application before it is submitted to City officials.

LOADING SHUTES CORRESPONDENCE

A letter from John Leffel was read concerning the loading shutes on the Fairgrounds. The scales repair bill was paid by the Livestock Association and Auction Committee. The scales were purchased by the sales from the livestock auction. Manager has written thank you letters to both groups.

The Rodeo Board August 23 minutes were reviewed by Fair Board. The Board concurred on several points: that only bills budgeted will be paid; that all invoices and statement be sent to the Fair Board; the budget problems need to be taken under advisement; recommend staying on the same system for ticket sales; Rodeo Board shall be responsible to the Fair Board regarding security; that ambulance be parked at North end as per usual; and that two performances (Fri. & Sat.) be held. Mrs. Hesse will check into weather insurance in case of rain. The Fair Board wishes to thank Larry Wyatt for doing a fine job on the rodeo.

FAIR 53 FORMAT

Manager recommended keeping the basic format of the 1977 Fair. The Fair will be open from 10 a.m. to 11 p.m. Pepsi Kid's Day will be changed to Pepsi Youth Day. There will be a charge for parking with parking attendants in hopes of alleviating some traffic problems. The parking attendants will be in direct employ of Fair Board. It was decided that the parking situation be tabled until such time that it can be fully reviewed.

POULTRY/RABBIT

Over \$300.00 was netted at a 4-H Fun Day according to Dan Wilson, Open Class Rabbit Superintendent. The money was put into a savings account by the Poultry/Rabbit Task Force, in hopes of blacktopping the Poultry/Rabbit building floor.

Vice-Chairman Jerry Boyer called the Board into executive session at 9:25 p.m.

MOTION: MOVED BY RALPH HOLLAND, SECONDED BY JIM SPRINGER, THAT THE BOARD ADOPT THE EMPLOYMENT AGREEMENT AS RELATING TO THE MANAGER OF THE WASHINGTON COUNTY FAIR FOR 1977-78 SEASON. MOTION CARRIED.

Addy Hesse will take the Manager's employment agreement and salary proposal under consideration. A decision will be made at the next meeting.

The Fair Board also approved hiring a full time parttime secretary with salary not to exceed \$5,100.00 annually. In addition, Mrs. Janet Holland will be interim bookkeeper. Mrs. Holland will be paid for expenses incurred, but asked not to receive a salary.

Vice-Chairman Boyer brought the Board out of executive session at 10:20~p.m.

BOARD INPUT

A letter from Pat Davis, a 1977 Fair entrant was received. Included in the letter were several suggestions for the 1978 Fair.

Jim Springer mentioned an idea of showing all one breed of cattle at one time at the Livestock Shows during the Fair.

ADJOURNMENT

The meeting was adjourned by Vice-Chairman Jerry Boyer at 10:40 p.m.
