THANK YOU

Jerry Boyer presented Addy Hesse, Valerie Bentley, Joan Erwert and Russ Dyche with a plaque of appreciation for each persons dedicated help during the 1981 Washington County Fair. Janet Holland was not present to receive her plaque.

QUEEN OF KITCHEN

The Board and Wanda and Ed Mulholland reviewed a letter from Nancy Mc-Williams. Mrs. McWilliams feels the Home Ec entries are becoming a competition of quantity instead of quality, and she suggested limiting the number of entries per person. Mrs. Mulholland doesn't think that would be a good idea. The two or three ladies who bring a large number of entries to compete for Queen of the Kitchen may become discouraged. Their entries really help fill up the department.

Colegrove suggested the ladies could choose which 100 entries would apply to Queen of the Kitchen competition. But there would be no limit on total entries. Boyer pointed out that only three people have over 100 entries; maybe more people would have 80 entries if they thought they would be in the competition. No matter how many entries a person has, the judging is still based on quality. The state fair limits only by space available.

Mrs. Mulholland pointed out that to be in the running for Queen of the Kitchen, one needs to enter both the baked goods and food preservation sections. The more rules for entering, the more paper work for the department.

The Board agreed no changes would be initiated immediately. Mrs. Mulholland will canvass other fairs concerning Queen of the Kitchen competition. Hesse will respond to Mrs. McWilliams by letter thanking her for input.

THEME

Mrs. Mulholland requested the Board consider a new theme for 1982. Exhibitors expressed to her they had used up all their ideas for the theme "Good Times," which was used for two years. The Board agreed to consider a new theme and asked the Mulhollands to submit their ideas.

Mrs. Mulholland asked about the possibility of getting a new building expressly for Home Economics. Display area is extremely overcrowded in the Main Exhibit Building; there are traffic problems; and there is no room for creativity. Hopefully, the 4-H department will be exhibiting in a new building which will open up extra area for home ec and textiles.

The Board and Mulhollands reviewed letters from Pat Davis and Millie Smith concerning the Home Ec department.

HOTEL/
MOTEL TAX

Board reviewed letter from Marge Post to owners and operators of Washington County hotels and motels. The 8 percent tax went into effect August 20, 1981.

C OF C LONG-RANGE Chamber of Commerce wrote to Hillsboro Planning Commission suggesting a committee be formed to maintain coordination of the development of the property in the vicinity of the fairgrounds.

Quandrant Corporation has received some pressure to develop property for a shopping center or other commercial use. Such development does not happen overnight. The Board is moving ahead for a zone change.

Boyer is interested in being the liaison between the Fair Board and Chamber of Commerce Long-Range Planning Committee. Mr. Boyer said more information on committee's activities will be available at the October Board meeting.

D. DERBY

Seventy-eight cars raced in the September 5, 1981, Destruction Derby. The drivers are becoming more aggressive and racing faster. There should be a 50 car limit with reservations first come, first served, and racing fees paid at time of reservation. There are more problems in the pit area too. Colegrove suggested raising the racing and pit fees in order to limit number of people in the pit area.

Time is a problem when such a large number of cars are racing. It took 1 hour to time the women and 1 hour 45 minutes to time the men drivers.

Hesse will arrange a breakfast meeting with a few destruction derby committee members and Boyer, Colegrove, and Pflug to discuss derby problems and possible solutions.

The Board is also concerned that the same group of people are helping with the derby every time. Soon the volunteers will be tired of helping. The Destruction Derby Committee should recruit some new help. If the Board had to hire all the manpower to run the derby, the September derby would have gone in the "red."

Hesse feels two derbies per year is just right. The third derby on Labor Day weekend cuts into the last three day weekend before school begins.

Board suggested eliminating the derby during the fair. Hesse explained the derby has greatly increased the fair gate on Wednesday. She thinks eliminating the Wednesday derby would hurt the gate. Limiting the number of cars will shorten the derby so the spectators can get back onto the grounds earlier. The derby during the fair has become a tradition and draws a group of people who probably would not attend the fair. The Board will talk with other fairs during the OFA convention for ideas.

M.E. ROOF

The Board reviewed Lorrie Maki's, Ray Kaufman's and Addy Hesse's account of Mr. Duyck's representations concerning the Main Exhibit Building roof. Unified Sewerage Agency sent the Board an unannounced bill for Yvonne Sherlock's legal services. Hesse, Boyer and Colegrove met with Greg Hathaway concerning the bill. Since the Board was not informed of such charges and did not budget for them, routine legal services will be gratis to the Fair Board until the 1982-83 fiscal year.

Sherlock is moving ahead with litigation on the roof matter.

P.A. SYSTEM The Board reviewed the P.A. system inventory. All agreed the fairgrounds finally has a good system.

MOTION: MOVED BY JERRY PFLUG, SECONDED BY MIKE SWAN TO REQUIRE A RE-FUNDABLE \$100 DEPOSIT WHEN THE P.A. SYSTEM IS USED WITH FAIRGROUNDS RENTAL. MOTION CARRIED.

Requiring a deposit is a built-in motivator for taking care of equipment.

FLORAL DEPT.

Marie Alberding has submitted her resignation as Open Class Floral Superintendent. Hesse will forward a letter of thanks to Mrs. Alberding.

Punky Benson resigned as Open Class Horse Superintendent. Several Board members have replacements in mind and will submit possible names at October Board meeting. Hesse will send a letter of thanks to Mrs. Benson.

WATER TRUCK MOTION: MOVED BY JERRY PFLUG, SECONDED BY AGNES DELASHMUTT TO ACCEPT AN OFFER OF EIGHT HOURS OF ELECTRICAL WORK IN EXCHANGE FOR THE OLD WATER TRUCK. MOTION CARRIED.

MERIT RATE The Board reviewed the post-fair information sent to the merit rater.

FINANCIAL RECAP

The 1981 fair gate is \$13,000 short of the budget. Some positive aspects: Carnival revenue was up and commercial exhibit revenue was up significantly.

4-H BLDG.

Hesse suggested hiring architect Herschell Plummer to provide preliminary sketches and building costs for finishing the 4-H Building. The Fair Board and 4-H people will give building requirement and use suggestions to the architect. The fairgrounds desperately needs a functional building during the winter months. The hotel/motel tax revenue will go towards completing the building. Hopefully, the building can be finished by the 1982 fair. In the past Mr. Plummer has done an excellent job. The Board instructed Director Hesse to have Mr. Plummer make a presentation to the Board.

FAIR MGRS CONFERENCE

MOTION: MOVED BY JERRY PFLUG, SECONDED BY AGNES DELASHMUTT TO AUTHORIZE DIRECTOR HESSE TO ATTEND THE FAIR MANAGERS AND DIRECTORS CONFERENCE IN SANTA CLARA, CALIFORNIA, ON NOVEMBER 17-20, 1981, EXPENSES NOT TO EXCEED \$550.00. MOTION CARRIED.

FAIR EVALUATION Boyer felt the fair ran very well although the extreme heat did hurt attendance. The spirit was congenial, and the grounds were extremely crowded in the evenings. He also thought the 97 Country Band was a real crowd pleaser.

KYTE Radio will be renting the fairgrounds on September 13 for "Free Day In The Country." The country music festival will be free. The 1980 attendance was 33,000. There will be 14 food concessions.

Swan feels putting flourescent lights in the barns is a necessity. The electrical panel for the arena area needs to be totally redone. Colegrove suggested utilizing the Sheriff's Building during the fair. Maybe the Fair Board office could be located in the Sheriff's Building. It would also be a good place to find some seclusion during the fair. Hesse pointed out the working conditions for the clerks was very cramped.

The water lines near the dairywives booth needs to be completely fixed, and water fountains and drains would be helpful near the Open Class Beef barn.

The Board commended Russ Dyche and the maintenance staff on how good the grounds looked when the fair began. All agreed the good condition of the grounds helped the exhibitors' dispositions.

Pflug thought the flower beds should be out near the center of the fairgrounds. Hesse has never had anyone to adequately work the flower beds, but this year a CETA worker did a wonderful job and it showed.

MOTION: MOVED BY MIKE SWAN, SECONDED BY AGNES DELASHMUTT TO PURCHASE 20 LIGHTS AT \$10 EACH. MOTION CARRIED.

Some of the ballasts are going bad. Boyer will sell ballasts to the fairgrounds at his cost through 1982.

A group suggested to Swan painting the buildings to match organizations. Since all different kinds of groups use the fairgrounds, the Board feels consistency and balance is more appropriate. Brighter colors would help to liven up the grounds. Groups and organizations are welcome to decorate with flags and banners.

FAIR DATES The Board is considering August 10-14 for 1982 fair dates. Davis Amusement and Hunkins have not confirmed those dates, so the Board will make a final decision on dates at the October 7 meeting.

BOARD Pflug and DeLashmutt's first three-year terms will be ending December 31, 1981. Pflug has indicated he will not be available to serve a second term. DeLashmutt is interested in serving another term. Both will write the Board of County Commissioners of their intentions. Boyer will be leaving the Fair Board after seven years of dedicated service.

SMALL CLAIM Jerry Norton and Gary Brown dba Holy Guacamole served a small claims court notice to the Fair Board and Addy Hesse individually. Boyer, Colegrove and Hesse consulted County Counsel concerning the Board's reaction. County Counsel felt Holy Guacamole had no solid grounds to build a case and advised the Fair Board to counterclaim for \$100 -- the maximum allowed by ORS 569.990. Small claims court does not allow attorneys or appeals. Court date should be some time near Christmas.

Hesse pointed out the Fair Board and staff should be covered by errors and omissions insurance in case something like this happens again. Pflug will check into the insurance.

Pflug felt the entire Board should have been notified of the claim, a special meeting called, and a decision made by the entire Board. The Board has worked closely in the past and should have done so in this instance. The Board should have seriously considered the consequences of legal action. Boyer and Hesse apologized for not notifying the entire Fair Board.

Hesse asked each member to reconstruct in writing the events concerning Holy Guacamole's claim as each remembered them.
