New to the San Diego County Fair, is our 24hr Film Festival. Groups of 3-10 people will have an opportunity to film on grounds with a designated area assigned to them. Each group will have 24 hrs to film, edit and submit their film. Each submission cannot exceed 10mins in running time. All footage must take place during the film festival 24 hour period. Any creative work in advance of the film festival is prohibited. Creative work includes, but is not limited to:

- Writing the script
- Rehearsing
- Shooting
- Editing
- Sound design

#### Eligibility:

- Employees of the San Diego County Fair (22<sup>nd</sup> District Agricultural Association /Del Mar Fairgrounds), its families, subsidiaries and affiliates are not eligible to compete.
- Open to all United States and Baja California residents.
- All entrants must be 16 years or older by June 1<sup>st</sup> 2017.
- Groups must have basic knowledge of video production.
- Attire and image, as well as content must be suitable for family viewing.
- Intoxication, use or possession of any controlled substance, or impolite, discourteous or obscene speech or conduct toward, or in hearing range of, the public or staff by participant or participant's group will be sufficient grounds to terminate your participation in this contest.

#### Entry Procedure

Please note that SDCF neither retains nor returns promotional materials. The SDCF is not responsible for late, lost, damaged, misdirected, stolen or misappropriated entries. Entry constitutes permission to use participants name, likeness, and performance for future advertising and publicity without additional compensation.

- Entries must be submitted online by the deadline **May 19 2017.** You will receive a confirmation receipt at the end of the application process.

- The application cannot be saved and returned to at a later date. Applicant must have all materials ready when beginning the application.
- **One** link of previous work is required, no longer than 30min. It is the applicant's responsibility to ensure that the links are functional prior to submission. (Nonfunctional and private links will result in disqualification).

#### Online Preliminary Judging:

Applicants will be judged on the following:

- Basic knowledge of video production
- Cinematography
- Sound quality
- Entertainment Value
- Creativity

The sole decision for selection rests with the Fair Management. The 22nd D.A.A./San Diego County Fair has the right to reject any application at its sole discretion. The judging panel consists of high-profile film industry professionals. Entrant acknowledges that all films entered may be distributed to judges who will be selecting the winners, and entrant agrees to release, indemnify, and hold the SDCF, its sponsors, and judges harmless for liability, damages, or claims for injury or loss to any person or property relating to, in whole or in part, directly or indirectly, participation in the SDCF competition. By entering this competition, the entrant agrees to accept and be bound by the decisions of the SDCF and its judges, which are final and binding in all matters.


#### Prizes:

Best Picture will receive a "MasterClass" from Masterclass.com



# **ESTRICTIONS**


Film crews are not allowed to film: Any backstage areas, ON any stages, In any restrooms or changing areas, At any food vendor area without permission Or on any rides.
