WTF&R provides water connections and 2 - 110-V 20-amp circuit electricity connections. **There will be a \$50 extra charge for each additional 110-V 20-amp, any 110-V 30-amp or higher and any 220-V electricity.** Facility power is rated 250-V 50-amp 4 wire maximum. If you require to be hard wired in, it is an additional cost of \$25 to have the electrician come in to hook you up, in addition to the cost of \$50 fee per amp higher than 120v. 100 amp is the highest amp available.

We do not provide garden hoses, faucet splitters, shovels, rakes, or tools of any kind.
