Plans for the 45th annual Wharton County Youth Fair are still on track! We're about to wrap up entry deadlines for projects, roasters will be here for pick up Friday, Feb. 5, and progress shows for Horses and Dairy will be held at the end of the month.

With only a few species left to go, here's an updated look at exhibitor entry numbers as of February. Dairy Merit Heifers – 11 exhibitors (3 in 2020); Pen of Three – 31 exhibitors (35 in 2020); Roasters – 11 exhibitors (14 in 2020) Commercial Heifers – 85 exhibitors (99 exhibitors in 2020); Steers – 32 exhibitors (41 exhibitors in 2020); Goats - 48 exhibitors (67 in 2020); Lambs - 19 exhibitors (22 in 2020); Broilers -18 exhibitors (24 in 2020) and Swine 117 exhibitors (137 in 2020).

Entry forms for Family Fun Night, Mutton Bustin' and Go Texan events will be on the web site by mid-March, when we are certain the shows and our Fair will go on!

Entry forms for all species are available on the web site. **Don't forget entry forms must be signed by the exhibitor, parent/guardian and FFA/4-H leader.** We must have a NEW release of liability on file for each exhibitor every year. First-time exhibitors must also turn in a completed W-9 form with the exhibitor's social security number, not a parents' number.

Reminder: A parent or guardian of any exhibitor with a project at the WCYF (excluding Bucket Calf) is required to work a minimum of three (3) hours per exhibitor.
