

Yes! And we are busy gearing up for the 44th annual Wharton County Youth Fair – Roaring 20's...Wharton County Style!

We're about to wrap up entry deadlines for projects, roasters will be here for pick up Friday (Feb. 7th) and progress shows for Horses and Dairy will be held at the end of the month.

With only a few species left to go, here's an updated look at exhibitor entry numbers as of last month. Dairy Merit Heifers – 3 exhibitors (6 in 2019); Pen of

Three – 35 exhibitors (49 in 2019); Roasters – 14 exhibitors (11 in 2019)
Commercial Heifers – 99 exhibitors (73 exhibitors in 2019); Steers – 41
exhibitors (40 exhibitors in 2019); Goats - 67 exhibitors (66 in 2019); Lambs -
22 exhibitors (31 in 2019); Broilers 24 exhibitors (same as 2019) and Swine
137 exhibitors (167 in 2019).


