## GENERAL INFORMATION

### PARKING RULES

- Automobiles and all other vehicles must be parked on space assigned by the Parking Department. All vehicles improperly parked will be towed away.
- Under no circumstances can automobiles be parked around buildings, in fire lanes, or in open areas throughout the central part of the grounds.
- Livestock trailer/truck parking in assigned areas. Camper parking in assigned areas with permit only. See Livestock Office.
- The Society will not be liable, under any circumstances, through negligence of itself, its agents, acts of third party, or otherwise, for injury to the person or property of the owner or occupant, for any property loss or damage.

### GENERAL RULES

1. **All rules and regulations referred to herein are made a part of the conditions under which entries are accepted and permits granted for exhibits and concessions.**
2. The Management reserves the right to interpret, amend or add to its rules and regulations.
3. Persons violating general, special rules or engaging in personal misconduct shall be subject to such penalty as the management may impose including forfeiture of all privileges and premiums.
4. The management encourages the reporting of mistreatment or extortion by concessionaires and any discourtesy or irregularity of its employees. Violation of local, State or Federal laws should be reported promptly to the Police Department.
5. **No pets, except properly identified service animals and properly identified service animals-in-training will be allowed anywhere on the fairgrounds. All service animals must remain leashed. Dogs, whether leashed or not, are prohibited on the grounds.**

### EXHIBITS AND EXHIBITORS

**Read carefully all rules pertaining to each department.**

1. Applications for entries of Livestock must be made on forms furnished by the Society in accordance with instructions and rules of the premium list.
2. Right is reserved to close entries before specified closing date. Entries cannot be changed after closing date.  
NO REFUNDS.
3. Entries must be made in the name of a bona fide owner. Violation of this rule shall work a forfeiture of premiums.
4. **All livestock must stay in the designated area.**
5. **The Management has the right to require any unhealthy animal to be removed from the Fair Grounds.**
6. All livestock entries (except steers, market goats, & companion goats) must be registered with their National Breed Association. Hereford cattle must be in the American Polled Hereford Association Record and or The American Hereford Assoc. All animals must have clearly legible tattoo identification and such identity must conform to the tattoo recorded on the official registry certificates.
7. **All exhibits must be delivered and removed at time indicated by rules of each department.**
8. Exhibits must be displayed in the manner requested by Department Superintendents.
9. **All livestock must be judged in order to be eligible for premiums.**
10. **Any exhibitor removing any of their animals from the barn before the release time will forfeit all their premium money.**
11. The posting and distribution of advertising matter is strictly prohibited other than in or from space occupied by exhibitor.
12. The Management assumes no responsibility for loss or damage to stock or exhibits from any cause.
13. The Management will take every precaution to protect the safety of stock or articles entered or shown after their arrival and placement; but under no circumstances will it be responsible for any loss, injury or damage done to, or occasioned by, or arising from any animal or article on exhibition, and the exhibitor shall indemnify the York County Agricultural Society for any and all damages.
14. The Society reserves the right to withhold awards where its rules and regulations are not complied with, where fraud or deception has been practiced, or where the exhibit does not merit an award.
15. Fair reserves the right to reject or disqualify any entry. In all cases, the decision of the management shall be final.
16. False representation, interference or misconduct by an exhibitor or his agent will be dealt with by the Director in Charge of the departments wherein the exhibit is entered. There will be no appeal from this decision.
17. Protests against awards must be in writing and indicate the reason there for and be filed with the Secretary not later than the day after the award is made. Protestants will be granted a hearing if deemed necessary, by the Management.
18. Payment of premiums will be made by check.
19. **Premium checks must be cashed within 30 days. Deadline for reporting any discrepancies in award checks is September 30<sup>th</sup>, 2022.**

## JUDGES

1. Exhibitors are not permitted to act as judges in a class in which he or she exhibits or is directly or indirectly interested.
2. Judges must not award prizes to an unworthy exhibit. In the absence of competition, or where only one exhibit is entered, 1st, 2nd, 3rd or no premiums will be awarded according to the merit of the exhibit.
3. Judges will make special mention of meritorious exhibits for which no premium is offered.
4. Interference with judges will not be permitted. Interfering exhibitors will be barred from competition.
5. All award books or sheets must be properly signed by the judges and returned to the head of the department immediately after the completion of awards.
6. In paying premiums, no evidence of awards will be recognized except the entry book and sheets, signed by superintendents and judges. Ribbons, cards, and labels that may be attached to the exhibits will not be recognized.
7. The decision of the judges will be final in all cases except where error, fraud, misrepresentation or collusion, not discovered at the time of the award, is proven. In such cases, the decision of the Management will be final.

- Initial bedding will be supplied and additional bedding available.
- Exhibitors should bring a wheelbarrow and shovel/rake for cleaning stalls.
- In the absence of competition in any class, the right is reserved to award the premium which the animals merit. Right is reserved to close entries before specified closing date.
- All applications received for entries, after the stall capacity is reached, will together with entry fees, be promptly returned.
- Entry money will be returned only if cancellation is received before July 13<sup>th</sup>, 2022.
- Dairy, Beef, & Dairy Beef Cattle, Sheep, Swine and Goats will be judged in Judging Rings.
- Animals suffering from a contagious disease will not be admitted to the grounds. If, through oversight, such animal is admitted, it will be removed immediately.
- No livestock to enter or exit through pedestrian doors.

## GUIDELINES FOR CARE OF ANIMALS

It is the responsibility of each exhibitor to care for animals in a manner that is responsible and ethical. Following are some guidelines for the treatment of animals exhibited at the show:

1. **Restraining Animals**
  - a) Animals will be tied or penned in a manner that will not hurt the animal or restrict its breathing in any way.
  - b) Animals will be tied so that all four feet are firmly on the ground and they have enough room to stand & lie down comfortably.
  - c) Animals should be tied so that they are not able to injure animals tied near them.
  - d) Animals unaccustomed to each other should not be penned together.
2. **Handling** - Any type of rough handling which could harm the animals is prohibited. The use of whips, canes, and show sticks should be restricted to showing only and then be used only to guide the animals, not punish them. Remember, animals will respond quicker and better to quiet, gentle handling, than loud, rough handling.
3. **Bedding** - All animals should have bedding that is dry and clean. Pens should be cleaned regularly to keep the animals clean and comfortable. If non-traditional bedding such as carpeting is used, it should be regularly cleaned (at least twice daily) to keep the pen free from manure.
4. **Feeding & Water** - Animals should be well fed and have access to clean water regularly. Realizing that market animals must have restricted amounts of feed to maintain the proper weight, animals must be fed adequate amounts of feed to meet the animal's basic requirements. Animals not allowed reasonable access to feed and water will be disqualified from the show.
5. **Transportation** - Animals should be transported in a way that is both safe and considerate of the animal's well-being.
6. **Blanket/Sweat Collars** - Any type of material such as blankets or sweat collars should be large enough to permit normal body functions such as breathing, eating, drinking or lying down.
7. **Health** - It is the responsibility of the exhibitor to provide proper health care for their animals through routine inspection and consultation with health care professionals. The improper or illegal use of drugs or antibiotics prohibited. If medication is indicated, be sure to follow the label directions and allow more than the state withdrawal time. **The exhibitor is responsible for all veterinary services during the fair.**

## 2022 YORK STATE FAIR CODE OF SHOW RING ETHIC

Exhibitors of animals at the York Fair shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at the livestock show.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and may be prohibited from future exhibition in accordance with the rules adopted by the commission. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

### The following is a list of GUIDELINES for all exhibitors and all livestock in competitive events:

1. All exhibitors must present, upon request of show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age or any fact relating there- to is prohibited.
2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by show officials.
3. Junior exhibitors are expected to care for and groom their animals while at the show.
4. Animals shall be presented to show events where they will enter the food chain free of volatile drug residues.
  - a. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event, which culminates with the animal entering the food chain, shall not be administered drugs other than in accordance with applicable federal and state statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal and state statutes, regulations and rules affect the animal's performance or appearance at the event.
  - b. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the approved laboratory to which it is sent is the one taken from the animal in question, its integrity is reserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise.
  - c. At any time after an animal arrives on the York Fair premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal, shall be administered by a licensed veterinarian or owner in consultation of a veterinarian.

## 2022 YORK STATE FAIR CODE OF SHOW RING ETHIC

5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation, or appearance, except external applications of substances to the hooves horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
7. Direct interference with the judge, show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
8. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics.
9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the Commission for the violation of this Code of Show Ring Ethics. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the Commission may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including Fairs and Expositions and any special notices to members.
11. The act of entering an animal in the show is the giving of verification by the owner, exhibitor, filter, trainer, or absolutely responsible person that he or she has read the Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal and state statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infraction.

### USE CAUTION WHEN FITTING YOUR ANIMALS

Be sure to use only grooming products that are approved for use on meat and dairy animals when fitting your animal for show. Unapproved products may contain ingredients that result in unacceptable residues in the meat or milk. If you are not certain that a product is residue safe and approved for use on meat or dairy animals, do not use it.

**\*\*Important!\*\* If upon slaughter, treatment with drugs, biologics, or any chemical from fitting products, is the cause of condemnation of a carcass, the loss of the carcass and any other damages will be borne by the exhibitor.**

In an effort to provide consumers with a safe, high quality product, the Junior Show Committee and the York State Fair, approve of the above statement. All 4-H and FFA market animals that will be sold at the Junior Livestock sale, should not use any fitting material that does not have USDA approval. Animals may be washed and blown dry but should not have any spray or substance that might be illegal. Any terminal animal that is found to violate this rule may not be sold on Friday, July 29<sup>th</sup>, 2022.

## Department 2 & 3 Animal Health Regulation CATTLE

### **Section 3: Pennsylvania Cattle:**

#### **Requirements:**


1. Cattle shall be identified by an official ear tag or other unique identification device approved by PDA. Official identification includes:
  - A USDA- issued National Uniform Ear tagging System (NUES) ear tag having a US shield ; or
  - A 15 digit Animal Identification Number (AIN) ear tag starting with "840" and having a US shield ; or
  - Other identification approved by the PDA (brands and breed registrations with tattoos are not acceptable).
2. Certificate of Veterinary Inspection (CVI) issued after May 1, 2022.
3. Rodeo: It is required that rodeo cattle of all ages be negative of an official tuberculin test within 60 days prior to the start of the fair unless they are members of and originate from an accredited tuberculosis-free herd. The cattle can be accompanied by the negative test report or the tuberculosis test results can be recorded by the veterinarian on a CVI.
4. All animals must be free of evidence of infectious and contagious diseases and a statement of this should be written on the CVI.

#### **Recommendations:**

1. A current rabies vaccination administered by a licensed veterinarian for animals 3 months of age and older (observe appropriate slaughter withdraw time.)

### **Section 4: Out of State Cattle:**

#### **Requirements:**

1. Federal regulations (USDA) require a Certificate of Veterinary Inspection (CVI) issued within the 30 days prior to the date of importation.
2. Vesicular Stomatitis (VS): This applies to cattle entering Pennsylvania from states that experienced a Vesicular Stomatitis outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals have neither been exposed to VS nor were located within 10 miles of a site where VS has been diagnosed."
3. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
4. Federal regulation (USDA) requires individual official animal identification. Official ID will have a US shield  and includes:
  - A USDA-issued National Uniform Eartagging System (NUES) tag; or
  - A 15-digit Animal Identification Number (AIN) ear tag starting with "840"; or
  - Other official identification approved by USDA (brands and breed registrations with tattoos are not acceptable).
5. Tuberculosis testing requirements:
  - No test is required for animals originating from states or zones designated as accredited free by the USDA.
  - All animals originating from states or zones designated modified accredited advanced by the USDA must be test negative within 60 days prior to the date of importation. The negative test results and dates of tests must be included on the CVI or the animal must be accompanied by a negatives test report (a copy of the original report is acceptable).
  - All animals originating from states or zones designated modified accredited by the USDA must originate from herds in which all animals 12 months of age and older are test negative within the 12 months prior to the date of importation and the individual animals (all ages) to be imported are also test negative within the 60 days prior to the date of importation and at least 60 days after the negative whole herd test was completed. The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original test report is acceptable).
  - **Special Tuberculosis Test requirement for Rodeo Cattle:** All rodeo cattle and bison from out of state must be negative on an official tuberculosis test within 60 days prior to entering Pennsylvania unless they originate from and are members of an Accredited Tuberculosis-free herd within an accredited Tuberculosis-free state or zone. This requirement for rodeo cattle from out of stat is in additional to all other requirements listed above for out of state cattle.

#### **Recommendations:**

1. A current rabies vaccination administered by a licensed veterinarian is recommended for animals 3 months of age and older (observe appropriate slaughter withdraw time).

  - A breed registration tattoo if the animals are accompanied by a registration certificate (copy acceptable) and the tattoo is legible.
2. For post-exhibition sales the following requirements apply:
  - Market sheep must be documented on sales slips which contain the following information:
    - i. Official identification (as described above)
    - ii. Sale date
    - iii. Sale location
    - iv. Name, address and phone number of the exhibitor
    - v. Hauler contact information
    - vi. Destination name and contact information
    - vii. Total number of animals in the shipment
    - viii. Type of sheep (i.e. meat, wool, specific breed)
    - ix. Signature of consignee agent, or hauler
      - Those slips must follow the sheep to their destination (including slaughter facilities).
  - Sheep which are purchased with the intent of breeding and are traveling via interstate movement must have a Certificate of Veterinary Inspection (ICVI) prior to movement to the destination state.
  - A Copy of the sale records slips and a copy of any ICVIs (state above) must be kept for 5 years.
3. A Certificate of Veterinary Inspection (CVI) issued within the 30 days prior to exhibition.
4. All animals must be free of evidence of infectious and contagious diseases and a statement of this should be written on the CVI.

##### **Recommendations:**

1. A current rabies vaccination administered by a licensed veterinarian for animals 3 months of age and older (observe appropriate slaughter withdraw time).

#### **Section 18: Out of State Sheep**

##### **Requirements:**

1. Federal regulation (USDA) requires a Certificate of Veterinary Inspection (CVI) issued within the 30 days prior to entry into PA.
2. Vesicular Stomatitis (VS) Statement: This applies to states that experienced a VS outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals were not located within 10 miles of a site where VS has been diagnosed."
3. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
4. Individual official USDA scrapie animal identification is required. Official scrapie ID includes:
  - A USDA ear tag with a US shield ; or
  - A legible tattoo with herd and individual identification recognized in an approved USDA Scrapie database a.k.a. scrapie tattoo (flock ID in the right ear—state postal code and letters/numbers—and individual animal ID in the left ear); or
  - A breed registration tattoo if the animals are accompanied by a registration certificate (copy acceptable) and the tattoo is legible.

## Animal Health Regulation Swine

### **Section 19: Pennsylvania Swine**

#### **Requirements:**

1. No swine species shall be exhibited in Pennsylvania unless each animal:
  - Is accompanied by a certificate of veterinary inspection (CVI) issued within 14 days of the fair;
  - Is permanently identified by an official 840 series radio frequency identification (RFID) ear tag and the ear tag number is recorded on the CVI;

### **DEPARTMENT 5**

- Has been visually inspected and found to be free of signs of contagious disease immediately prior to unloading at the exhibition by an accredited veterinarian or swine health monitor appointed by the fair board or livestock show committee.
2. All breeding swine exhibitions are to occur prior to the arrival of any market swine
    - Breeding swine must be removed from the animal exhibition premises prior to any market swine arriving.
    - Breeding swine animal exhibitions shall arrive, exhibit, and depart in a period no greater than 72 hours.
    - Swine birthing exhibitions and educational displays which are not competing may occur concurrently with market swine animal exhibition, as long as, reasonable precaution is made to ensure the biosecurity of the swine birthing exhibition or educational display.
  3. All market swine exhibited in department sponsored market shows shall move directly to a PDA or USDA licensed slaughter facility following the animal exhibition and may not be diverted to premises other than a recognized slaughter establishment or a slaughter market in which the sales are designated slaughter only sales.
  4. Non-PDA sponsored shows including jackpot shows and 4-H round-ups, not occurring during a PDA sponsored fair or show are exempt from the terminal slaughter requirement only if the following conditions are adhered to:
    - As is stated above, the swine shall be accompanied by a certificate of veterinary inspection issued within 14 days of the exhibition and shall be permanently identified by an 840 series radio frequency (RFID) identification ear tag.
    - Arrival, exhibition and departure of the swine occur within a 72-hour window.
    - There is no public access to the animals other than observation during competitions.
    - An Accredited Veterinarian or trained swine health monitor visually inspects the animals prior to unloading, and they are found to be free of signs of contagious disease.
    - An Accredited Veterinarian or trained swine health monitor shall monitor and record the health of the pigs daily for signs of contagious disease and the accredited Veterinarian shall immediately report all suspicious disease to the State Animal Health Official.
    - A Veterinary-client-patient-relationship is established between the show committee/management staff and an accredited Veterinarian, and that Veterinarian is readily available for health monitoring, emergency coverage, treatment, follow up evaluation, and prompt reporting of suspicious disease to the State Animal Health Official.

### **Section 20: Out of State Swine**

#### **Requirements:**

1. A Certificate of Veterinary Inspection (CVI) issued within the 14 days prior to the date of the show is required. The CVI shall include a statement verifying that the swine have not been fed raw garbage.
2. Vesicular Stomatitis (VS) Statement: This applies to states that experienced a VS outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals were not located within 10 miles of a site where VS has been diagnosed."
3. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
4. Has been visually inspected and found to be free of signs of contagious disease immediately prior to unloading at the exhibition by an accredited veterinarian or swine health monitor appointed by the fair board or livestock show committee.
5. Individual animal ID- must be permanently identified by an official 840 series radio frequency identification (RFID) ear tag and the ear tag number is recorded on the CVI.
6. Brucellosis Testing Requirements:
  - a. No test required if the animal originates from a validated brucellosis-free state or brucellosis-free herd. All others must be tested negative within the 30 days prior to the date of importation.
7. Pseudorabies Testing Requirements:

- a. Sexually intact swine over 6 months of age shall originate from a qualified PRV negative herd or be test negative to an official pseudorabies test within 30 days prior to importation.
- b. No pseudorabies testing required for all other swine.
- 8. All breeding swine exhibitions are to occur prior to the arrival of any market swine:
  - a. Breeding swine must be removed from the animal exhibition premises prior to any market swine arriving.
  - b. Breeding swine animal exhibitions shall arrive, exhibit, and depart in a period no greater than 72 hours.
  - c. Swine birthing exhibitions and educational displays which are not competing may occur concurrently with market swine animal exhibition, as long as, reasonable precaution is made to ensure the biosecurity of the swine birthing exhibition or educational display.
- 9. All market swine exhibited in Department sponsored Market shows shall move directly to a PDA or USDA licensed slaughter facility following the animal exhibition and may not be diverted to premises other than a recognized slaughter establishment or a slaughter market in which the sales are designated slaughter only sales.
- 10. Non- PDA sponsored shows including jackpot shows and 4-H round-ups not occurring during a PDA sponsored fair or show are exempt from the terminal slaughter requirement only if the following conditions are adhered to:
  - a. As is stated above, the swine shall be accompanied by a certificate of veterinary inspection issued within 14 days of the exhibition and shall be permanently identified by an 840 series radio frequency (RFID) identification ear tag

- b. Arrival, exhibition and departure of the swine occur within a 72-hour window.
- c. There is no public access to the animals other than observation during competitions.
- d. An Accredited Veterinarian or trained swine health monitor visually inspects the animals prior to unloading, and they are found to be free of signs of contagious disease.
- e. An accredited Veterinarian or trained swine health monitor shall monitor and record the health of the pigs daily for signs of contagious disease and the accredited Veterinarian shall immediately report all suspicious disease to the State Animal Health Official.
- f. A Veterinary-client-patient-relationship is established between the show committee/management staff and an accredited Veterinarian, and that Veterinarian is readily available for health monitoring, emergency coverage, treatment, follow up evaluation, and prompt reporting of suspicious disease to the State Animal Health Official.

### Section 11: Pennsylvania Goats

#### **Requirements:**

1. Individual official animal identification is required for all goats. Official ID includes:
  - A breed registration tattoo if the animal is accompanied by a registration certificate and the tattoo is legible OR
  - A USDA ear tag with a US shield ; which includes scrapie program tags (animals bearing identification with blue colored scrapie program tags are not permitted to be exhibited in Pennsylvania) OR
  - A legible tattoo with herd and individual identification recognized in an approved USDA Scrapie database a.k.a. scrapie tattoo (flock ID in the right ear—state postal code and letters/numbers—and individual animal ID in the left ear);
  - Identification used for goats must be permanently affixed to the individual animal.
2. A Certificate of Veterinary Inspection (CVI) issued after May 1, 2022.
3. All animals must be free of evidence of infectious and contagious diseases; a statement of this should be written on the CVI.

### Section 12: Out of State Goats

#### **Requirements:**

1. A Certificate of Veterinary Inspection (CVI) issued within 30 days prior to the date of importation.
2. Vesicular Stomatitis (VS) statement: This applies to states that experienced a VS outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals were not located within 10 miles of a site where VS has been diagnosed."
3. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
4. Individual official animal identification is required for all goats. Official ID includes:
  - a. A breed registration tattoo if the animal is accompanied by a registration certificate and the tattoo is legible.
  - b. A USDA ear tag with a US shield ; which includes scrapie program tags (animals bearing identification with blue colored scrapie program tags are not permitted to be exhibited in Pennsylvania) OR
  - c. A legible tattoo with herd and individual identification recognized in an approved USDA Scrapie database a.k.a. scrapie tattoo (flock ID in the right ear—state postal code and letters/numbers—and individual animal ID in the left ear); OR
5. Tuberculosis testing requirements:
  - a. No test is required for animals originating from states or zones designated as accredited-free by the USDA.
  - b. All animals originating from states or zones designated modified accredited advanced by the USDA must be test negative within the 60 days prior to the date of importation. The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original report is acceptable).
  - c. All animals originating from states or zones designated modified accredited must originate from herds in which all animals 12 months of age and older have tested negative within the 12 months prior to the date of importation; and the individual animals (all ages) to be imported have also tested negative within the 60 days prior to the date of importation and at least 60 days after the negative whole herd test was completed. The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original test report is acceptable).

#### **Recommendations:**

1. All out of state goats must meet all criteria listed above as "requirements". PDA has no additional recommendations to prevent the introduction of contagious disease from out of state goats.

## **Department 51 & 52**

### **Animal Health Regulation**

#### **Section 3: Pennsylvania Cattle:**

##### **Requirements:**


1. Cattle shall be identified by an official ear tag or other unique identification device approved by PDA. Official identification includes:
  - A USDA- issued National Uniform Ear tagging System (NUES) ear tag having a US shield ; or
  - A 15 digit Animal Identification Number (AIN) ear tag starting with "840" and having a US shield ; or
  - Other identification approved by the PDA (brands and breed registrations with tattoos are not acceptable).
2. Certificate of Veterinary Inspection (CVI) issued after May 1, 2022.
3. Rodeo: It is required that rodeo cattle of all ages be negative of an official tuberculin test within 60 days prior to the start of the fair unless they are members of and originate from an accredited tuberculosis-free herd. The cattle can be accompanied by the negative test report or the tuberculosis test results can be recorded by the veterinarian on a CVI.
4. All animals must be free of evidence of infectious and contagious diseases and a statement of this should be written on the CVI.

##### **Recommendations:**

1. A current rabies vaccination administered by a licensed veterinarian for animals 3 months of age and older (observe appropriate slaughter withdraw time.)

#### **Section 4: Out of State Cattle:**

##### **Requirements:**

1. Federal regulations (USDA) require a Certificate of Veterinary Inspection (CVI) issued within the 30 days prior to the date of importation.
2. Vesicular Stomatitis (VS): This applies to cattle entering Pennsylvania from states that experienced a Vesicular Stomatitis outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals have neither been exposed to VS nor were located within 10 miles of a site where VS has been diagnosed."
3. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
4. Federal regulation (USDA) requires individual official animal identification. Official ID will have a US shield  and includes:
  - A USDA-issued National Uniform Eartagging System (NUES) tag; or
  - A 15-digit Animal Identification Number (AIN) ear tag starting with "840"; or
  - Other official identification approved by USDA (brands and breed registrations with tattoos are not acceptable).
5. Tuberculosis testing requirements:
  - No test is required for animals originating from states or zones designated as accredited free by the USDA.
  - All animals originating from states or zones designated modified accredited advanced by the USDA must be test negative within 60 days prior to the date of importation. The negative test results and dates of tests must be included on the CVI or the animal must be accompanied by a negatives test report (a copy of the original report is acceptable).
  - All animals originating from states or zones designated modified accredited by the USDA must originate from herds in which all animals 12 months of age and older are test negative within the 12 months prior to the date of importation and the individual animals (all ages) to be imported are also test negative within the 60 days prior to the date of importation and at least 60 days after the negative whole herd test was completed. The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original test report is acceptable).
  - **Special Tuberculosis Test requirement for Rodeo Cattle:** All rodeo cattle and bison from out of state must be negative on an official tuberculosis test within 60 days prior to entering Pennsylvania unless they originate from and are members of an Accredited Tuberculosis-free herd within an accredited Tuberculosis-free state or zone. This requirement for rodeo cattle from out of stat is in additional to all other requirements listed above for out of state cattle.

##### **Recommendations:**

1. A current rabies vaccination administered by a licensed veterinarian is recommended for animals 3 months of age and older (observe appropriate slaughter withdraw time).

12. **Registered and unregistered** market animals (both pure and crossbred) and **registered** Sovereign heifers, will be included for the number of animals in a point show.
13. Only **registered** pure and crossbred market animals and **registered** Sovereign heifers will count toward the Premier Breeder and Exhibitor awards at all ROE shows.
14. Animals in group classes Get-of-Sire, Produce-of-Dam and Breeders Herd must be registered purebred Highland cattle.

**Youth Rules & Regulations:**

- YOUTH EXHIBIT I — 4-H Members and Clubs:** Eligible to Exhibit: York County 4-H Club members (active) carrying a project under the supervision of the Pennsylvania State University / York County Extension Service. Age of members will be determined as of January 1 of the current year for classes where members enter based on age. 4-H members 8-18 years old (as of Jan. 1<sup>st</sup>) are eligible to enter the junior livestock show.
- YOUTH EXHIBIT II — Vocational:** Eligible to Exhibit: FFA members and/or students enrolled in an accepted York County vocational school curriculum carrying a project in classes entered. Age of members will be determined as of January 1 of the current year for classes where members enter based on age.
  - Members who have not passed their 21<sup>st</sup> birthday by January 1 of the current year are eligible to enter the junior livestock show.**
- All Livestock entries are required to meet **2022 Pennsylvania Animal Livestock Health Requirements**
- Youth exhibitors are reminded to observe all general and special rules and conduct themselves in a proper way on the Fairgrounds in order to avoid forfeiture of privileges and/or premiums.**
- Youth Showmanship Age is the age of the exhibitor as of January 1<sup>st</sup> of the current year.**
- Youth Members may show either a breeding or market animal in the showmanship and/or fitting shows.**
  - The animal must be owned by the exhibitor. Exceptions MUST be approved by the department superintendent and only for circumstances outside the exhibitors control.**

### Youth PeeWee Showmanship

The PeeWee Showmanship is for youth 5 - 7 years old by the date of the show. PeeWee classes will be included in the Beef, Sheep, Swine, Dairy, Dairy Beef, Goats and Alpaca shows. Each species superintendent will post the time of the PeeWee class. Participants, especially in Beef, are encouraged to have an older 4-H or FFA member assist them in the ring while exhibiting their animal. Each participant will receive a ribbon and additional items to be determined by the class sponsor. PeeWee participants will not receive premiums. All PeeWee participants MUST inform the species superintendent during check in if they wish to participate in the PeeWee class.

### Youth Supreme Market Animal Contest

The Supreme Champion Market Animal will be selected by a representative from each species: beef, dairy beef, meat goats, sheep, & swine. Each species representative will evaluate the Grand Champion Youth Market animal from each species: beef, dairy beef, meat goats, sheep, & swine. They are to keep in mind the primary function of the market animal is for meat production. Frame size & structural correctness are examined, but to a slightly lesser degree than in the breeding portion of each species.

The panel of judges will be given a score sheet. They will not be able to vote for their species. Each judge will give the species they represent a "0" and rank the other animals 1-2-3-4. Rank according to the first place – most ideal supreme market animal. 1 for the most ideal market animal, 2 for the second choice, 3 for the third choice, and 4 for the animal that is the least ideal. The animal with the least points will be the Supreme Market Animal. All decisions are final. There is no monetary award, but the Youth Supreme Market Animal will be the first animal to sell in the Junior Livestock Sale. The contest is meant to be fun & educational to the public.

### Youth Supreme Showmanship Contest

Each species will have the opportunity to have the Grand Champion Showman for that species compete in a Round Robin competition for the York State Fair Supreme Youth Showman. If the same exhibitor wins more than one species Grand Champion Showman, they will represent all the species that they are the Grand Champion showman for. The species that will be represented are: Beef, Dairy Beef, Meat Goats, Sheep, and Swine.

Each species Department Superintendent will select five animals to be used in the competition & will supply the representatives with the proper equipment to show that species in the ring. Regardless of what species the showman is representing they are not allowed to use their own animal in the competition. The department superintendent may select their animal to be used, but the exhibitor must use one of the other animals the department superintendent has selected. The Department Superintendents will ask the owner for permission to use their animal during the Youth Supreme Showmanship Contest.

A representative from each species will judge the corresponding species portion of the contest. The judges will give each participant a score from 1-10. A "10" would indicate a perfect showman. The judge may award more than the same numeric value to more than one participant. Example: They may assign a 10 to one showman and another two members could be assigned an 8.

Scores will be collected and tallied. The member receiving the most points will be awarded the title. There will be no premiums associated with this contest. In the event of a tie, an impromptu question will be asked of each participant. The participant with the closest correct answer will win the competition.
