GENERAL INFORMATION

PARKING RULES

- Automobiles and all other vehicles must be parked on space assigned by the Parking Department. All vehicles improperly parked will be towed away.
- Under no circumstances can automobiles be parked around buildings, in fire lanes, or in open areas throughout the central part of the grounds.
- Livestock trailer/truck parking in assigned areas. Camper parking in assigned areas with permit only. See Livestock Office.
- The Society will not be liable, under any circumstances, through negligence of itself, its agents, acts of third party, or otherwise, for injury to the person or property of the owner or occupant, for any property loss or damage.

GENERAL RULES

1. **All rules and regulations referred to herein are made a part of the conditions under which entries are accepted and permits granted for exhibits and concessions.**
2. The Management reserves the right to interpret, amend or add to its rules and regulations.
3. Persons violating general, special rules or engaging in personal misconduct shall be subject to such penalty as the management may impose including forfeiture of all privileges and premiums.
4. The management encourages the reporting of mistreatment or extortion by concessionaires and any discourtesy or irregularity of its employees. Violation of local, State or Federal laws should be reported promptly to the Police Department.
5. **No pets, except properly identified service animals and properly identified service animals-in-training will be allowed anywhere on the fairgrounds. All service animals must remain leashed. Dogs, whether leashed or not, are prohibited on the grounds.**

EXHIBITS AND EXHIBITORS

Read carefully all rules pertaining to each department.

1. Applications for entries of Livestock must be made on forms furnished by the Society in accordance with instructions and rules of the premium list.
2. Right is reserved to close entries before specified closing date. Entries cannot be changed after closing date.
NO REFUNDS.
3. Entries must be made in the name of a bona fide owner. Violation of this rule shall work a forfeiture of premiums.
4. **All livestock must stay in the designated area.**
5. **The Management has the right to require any unhealthy animal to be removed from the Fair Grounds.**
6. All livestock entries (except steers, market goats, & companion goats) must be registered with their National Breed Association. Hereford cattle must be in the American Polled Hereford Association Record and or The American Hereford Assoc. All animals must have clearly legible tattoo identification and such identity must conform to the tattoo recorded on the official registry certificates.
7. **All exhibits must be delivered and removed at time indicated by rules of each department.**
8. Exhibits must be displayed in the manner requested by Department Superintendents.
9. **All livestock must be judged to be eligible for premiums.**
10. **Any exhibitor removing any of their animals from the barn before the release time will forfeit all their premium money.**
11. The posting and distribution of advertising matter is strictly prohibited other than in or from space occupied by exhibitor.
12. The Management assumes no responsibility for loss or damage to stock or exhibits from any cause.
13. The Management will take every precaution to protect the safety of stock or articles entered or shown after their arrival and placement; but under no circumstances will it be responsible for any loss, injury or damage done to, or occasioned by, or arising from any animal or article on exhibition. The exhibitor shall indemnify the York County Agricultural Society for any and all damages caused by any animal or article.
14. The Society reserves the right to withhold awards where its rules and regulations are not complied with, where fraud or deception has been practiced, or where the exhibit does not merit an award.
15. Fair reserves the right to reject or disqualify any entry. In all cases, the decision of the management shall be final.
16. False representation, interference or misconduct by an exhibitor or his agent will be dealt with by the Director in Charge of the departments wherein the exhibit is entered. There will be no appeal from this decision.
17. Protests against awards must be in writing and indicate the reason there for and be filed with the Secretary not later than the day after the award is made. Protestants will be granted a hearing if deemed necessary, by the Management.
18. Payment of premiums will be made by check.
19. **Premium checks must be cashed within 30 days. Deadline for reporting any discrepancies in award checks is September 30th, 2024.**

JUDGES

1. Exhibitors are not permitted to act as judges in a class in which he or she exhibits or is directly or indirectly interested.
2. Judges must not award prizes to an unworthy exhibit. In the absence of competition, or where only one exhibit is entered, 1st, 2nd, 3rd or no premiums will be awarded according to the merit of the exhibit.
3. Judges will make special mention of meritorious exhibits for which no premium is offered.
4. Interference with judges will not be permitted. Interfering exhibitors will be barred from competition.
5. All award books or sheets must be properly signed by the judges and returned to the head of the department immediately after the completion of awards.
6. In paying premiums, no evidence of awards will be recognized except the entry book and sheets, signed by superintendents and judges. Ribbons, cards, and labels that may be attached to the exhibits will not be recognized.
7. The decision of the judges will be final in all cases except where error, fraud, misrepresentation or collusion, not discovered at the time of the award, is proven. In such cases, the decision of the Management will be final.

- Each exhibitor is required to turn in a VCPR with all of their exhibited animals list on it to their Superintendent.
 - a. If the exhibitor is showing multiple species, please turn the VCPR into first Species Superintendent.
- Initial bedding will be supplied and additional bedding available.
- Exhibitors should bring a wheelbarrow and shovel/rake for cleaning stalls.
- In the absence of competition in any class, the right is reserved to award the premium which the animal's merit. Right is reserved to close entries before specified closing date.
- All applications received for entries, after the stall capacity is reached, will together with entry fees, be promptly returned.
- Dairy, Beef, & Dairy Beef Cattle, Sheep, Swine and Goats will be judged in Judging Rings.
- Animals suffering from a contagious disease will not be admitted to the grounds. If, through oversight, such animal is admitted, it will be removed immediately.
- No livestock to enter or exit through pedestrian doors.

- Livestock must remain in the barn other than the tie-out area (Cattle ONLY) and exercise ring.
- During the fair NO animal will be tied out prior to 8:30 P.M.
- ALL animals must be washed and out of the wash area 15 minutes prior to show time.
- Exhibitors may put down mats, tar paper, etc. Exhibitors must remove all mats, tar paper, etc. and any tape used to hold it down before they leave. Premiums will be forfeited if not removed.
 - Only Gaffers tape may be used!!
- Pens must be left in the same condition or better when exhibitors are released. Premiums will be forfeited if not in the same condition.

2024 YORK STATE FAIR CODE OF SHOW RING ETHICS

Exhibitors of animals at the York State Fair shall always exhibit themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at the livestock show. All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and may be prohibited from future exhibition in accordance with the rules adopted by the commission. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of REQUIREMENTS for all exhibitors & all livestock in competitive events:

1. All exhibitors must present, upon request of show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age or any fact relating there- to is prohibited.
2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by show officials.
3. Junior exhibitors are expected to care for and groom their animals while at the show.
4. Animals shall be presented to show events where they will enter the food chain free of volatile drug residues.
 - a. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event, which culminates with the animal entering the food chain, shall not be administered drugs other than in accordance with applicable federal and state statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal and state statutes, regulations and rules affect the animal's performance or appearance at the event.
 - b. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the approved laboratory to which it is sent is the one taken from the animal in question, its integrity is reserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise.
 - c. At any time after an animal arrives on the York State Fair premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal, shall be administered by a licensed veterinarian or owner in consultation of a veterinarian.
5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation, or appearance, except external applications of substances to the hooves horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
7. Direct interference with the judge, show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
8. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics.
9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the Commission for the violation of this Code of Show Ring Ethics. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the Commission may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including Fairs and Expositions and any special notices to members.
11. The act of entering an animal in the show is the giving of verification by the owner, exhibitor, filter, trainer, or absolutely responsible person that he or she has read the Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal and state statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infraction.

**2024 YORK STATE FAIR
CODE OF SHOW RING ETHICS
REQUIREMENTS FOR CARE OF ANIMALS:**

It is the responsibility of each exhibitor to care for animals in a manner that is responsible and ethical. Following are some requirements for the treatment of animals exhibited at the show:

1. Restraining Animals

- a. Animals will be tied or penned in a manner that will not hurt the animal or restrict its breathing in any way.
- b. Animals will be tied so that all four feet are firmly on the ground and they have enough room to stand & lie down comfortably.
- c. Animals should be tied so that they are not able to injure animals tied near them.
- d. Animals unaccustomed to each other should not be penned together.

2. Handling - Any type of rough handling which could harm the animals is prohibited. The use of whips, canes, and show sticks should be restricted to showing only and then be used only to guide the animals, not punish them. Remember, animals will respond quicker and better to quiet, gentle handling, than loud, rough handling.

3. Bedding - All animals should have bedding that is dry and clean. Pens should be cleaned regularly to keep the animals clean and comfortable. If non-traditional bedding such as carpeting is used, it should be regularly cleaned (at least twice daily) to keep the pen free from manure.

4. Feeding & Water - Animals should be well fed and have access to clean water regularly. Realizing that market animals must have restricted amounts of feed to maintain the proper weight, animals must be fed adequate amounts of feed to meet the animal's basic requirements. Animals not allowed reasonable access to feed and water will be disqualified from the show.

5. Transportation - Animals should be transported in a way that is both safe and considerate of the animal's well-being.

6. Blanket/Sweat Collars - Any type of material such as blankets or sweat collars should be large enough to permit normal body functions such as breathing, eating, drinking or lying down.

7. Health - It is the responsibility of the exhibitor to provide proper health care for their animals through routine inspection and consultation with health care professionals. The improper or illegal use of drugs or antibiotics prohibited. If medication is indicated, be sure to follow the label directions and allow more than the state withdrawal time. **The exhibitor is responsible for all veterinary services during the fair.**

8. Market Animals – Animals consigned for slaughter during or immediately following the show shall not receive any treatment with drugs or biologics within in the withdrawal time prior to slaughter. Withdrawal times for drugs and biologics are all stated on the directions for use. Label directions must be followed at all times.

9. Grooming – Use only grooming products that are approved for use on meat-producing animals when fitting any animal for show. Unapproved products may contain ingredients that result in unacceptable residues in the meat. If it is not certain that a product is residue safe and approved for use on meat animals, **DO NO USE IT!**

10. Unethical Fitting: Any animal showing any evidence of unethical fitting practices such as tampering with the natural fleshing and muscle development (including but NOT limited to drenching and pumping of fluids) will be barred from the show and no premiums will be awarded. **NO exhibitors shall be allowed to use any coloring agents on any animal exhibited. No aerosol cans or other pressurized containers will be allowed outside of stall/tack/fitting areas (i.e. not allowed ringside).** Altering the conformation and/or appearance of an animal for exhibition is prohibited, this includes the covering of white skin, false tail heads (or use of any false hair or other material), with the exception of false tail switches. The use of graphite, powders, hemp, or other similar substances used externally are also prohibited. Other prohibited products include those used internally such as steroids, illegal or unlicensed pharmaceuticals, or artificial filling. Any animal found to be in violation will be barred from showing.

*****IMPORTANT***** If upon slaughter, treatment with drugs, biologics, or any chemical from fitting products, is the cause of condemnation of a carcass, the loss of the carcass and any other damages will be borne by the exhibitor. In an effort to provide consumers with a safe, high quality product, the Junior Show Committee & the York State Fair, approve of the above statement. All 4-H & FFA market animals that will be sold at the Junior Livestock sale, should not use any fitting material that does not have USDA approval. Animals may be washed and blown dry but should not have any spray or substance that might be illegal. Any terminal animal that is found to violate this rule may not be sold on Friday, July 26th, 2024.

By signing, exhibitor verifies that they have read, understands, consents to, & agrees to abide by the terms & conditions state herein in the 2024 York State Fair Code of Show Ring Ethics, failure to follow the rules listed above will result in either an official written warning (only 1 written warning before excusal) or an immediate excusal from the fair &/or withholding of all premiums for the 2024 York State Fair & the exhibitor may be prohibited from exhibiting at the York State Fair for up to three (3) years. All decisions will be made by the York State Fair Livestock Executive Members.

Department 2 & 3 Animal Health Regulation CATTLE

Section 3: Pennsylvania Cattle:

Requirements:


1. Cattle shall be identified by an official ear tag or other unique identification device approved by PDA. Official identification includes:
 - A USDA- issued National Uniform Ear tagging System (NUES) ear tag having a US shield ; or
 - A 15 digit Animal Identification Number (AIN) ear tag starting with "840" and having a US shield 
2. **Certificate of Veterinary Inspection (CVI) issued 30 days prior to the date of exhibition.**
 - CVI's must include the following statement written on them: All animals must be free evidence of infectious and contagious diseases.
3. Rodeo: It is required that rodeo cattle of all ages be negative of an official tuberculin test within 60 days prior to the start of the fair unless they are members of and originate from an accredited tuberculosis-free herd. The cattle can be accompanied by the negative test report or the tuberculosis test results can be recorded by the veterinarian on a CVI or VCPR.

Recommendations:

1. A current rabies vaccination administered by a licensed veterinarian is recommended for animals 3 months of age and older (observe appropriate slaughter withdraw time).

Section 4: Out of State Cattle:

Requirements:

1. Federal regulations (USDA) require a Certificate of Veterinary Inspection (CVI) issued within the 30 days prior to the date of importation.
2. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
3. Vesicular Stomatitis (VS): This applies to cattle entering Pennsylvania from states that experienced a Vesicular Stomatitis outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals have neither been exposed to VS nor were located within 10 miles of a site where VS has been diagnosed."
4. Federal regulation (USDA) requires individual official animal identification for all cattle of any age of exhibition. Official ID will have a US shield  and includes:
 - a. A USDA-issued National Uniform Eartagging System (NUES) tag; or
 - b. A 15-digit Animal Identification Number (AIN) ear tag starting with "840"; or
5. Tuberculosis testing requirements:
 - a. No test is required for animals originating from states or zones designated as accredited free by the USDA.
 - b. All animals originating from states or zones designated modified accredited advanced by the USDA must be test negative within 60 days prior to the date of importation. The negative test results and dates of tests must be included on the CVI or the animal must be accompanied by a negatives test report (a copy of the original report is acceptable).
 - c. All animals originating from states or zones designated modified accredited by the USDA must originate from herds in which all animals 12 months of age and older are test negative within the 12 months prior to the date of importation and the individual animals (all ages) to be imported are also test negative within the 60 days prior to the date of importation and at least 60 days after the negative whole herd test was completed. The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original test report is acceptable).
 - d. **Special Tuberculosis Test requirement for Rodeo Cattle:** All rodeo cattle and bison from out of state must be negative on an official tuberculosis test within 60 days prior to entering Pennsylvania unless they originate from and are members of an Accredited Tuberculosis-free herd within an accredited Tuberculosis-free state or zone. This requirement for rodeo cattle from out of state is in addition to all other requirements listed above for out of state cattle.
6. **Out of State Dairy Cattle ONLY in accordance with the Quarantine issued Saturday, April 20, 2024:**
 - a. **Importation Standards:** All dairy cattle entering Pennsylvania shall meet all requirements established in the Domestic Animal Law (3 Pa.C.S 2301-2390), the Department's regulations at Title 7 of the *Pennsylvania Code* and in this Quarantine Order.

- b. **Movement Restrictions:** Dairy Cattle from a premises where Influenza A Virus has been confirmed in dairy cattle, or where the premises meets the UDA case definition, may not be imported into the Commonwealth until the premises has been declared free of disease by the respective State Animal Health Official.
- c. **Testing Requirements:** Except as proved in subsection xxii., dairy cattle from a State, Commonwealth, foreign nation, province, or territory where Influenza A Virus has been confirmed in dairy cattle within the past 30 days may not be imported into, stopped off in, or unloaded in Pennsylvania without meeting the following testing requirements for Influenza A Virus:
- i. A representative sample of 30 animals in each shipment must be tested for Influenza A Virus within 5 days prior to movement.
 - ii. If a shipment contains 30 or fewer animals, all animals in the shipment must be tested within 5 days prior to movement.
 - iii. The animals in each shipment must have been assembled as a group for a period of at least 30 days prior to testing in accordance with subsections i and ii above. New animals may not have been added to the herd or group within the 30 day period preceding testing.
 - iv. Where the requirements established in subsection iii above have not been or cannot be complied with, all animals in the shipment, no matter the size of the shipment, must be tested in accordance with subsection ii above.
 - v. Milk specimens, nasal swabs and samples as required in subsection vi and vii of this section must be collected and submitted by or under the supervision of an Accredited Veterinarian (Category II).
 - vi. Nasal swabs must be collected for testing in accordance with the provisions of this section from each non-lactating animal on a shipment. Nasal swabs shall be collected in a manner that is in accordance with National Veterinary Services Laboratory guidance provided to the testing laboratory.
 - vii. A milk specimen must be collected for testing in accordance with the provisions of this section from each lactating animal on a shipment. Milk specimens must be collected in a manner that is in accordance with National Veterinary Services Laboratory guidance to the testing laboratory.
 - viii. Each specimen or sample collected under subsections vi and vii must be tested for Influenza A Virus using polymerase chain reaction (PCR) testing and protocol approved by NVSL.
 - ix. Testing of all specimens or samples collected under subsections vi and vii must be performed at a NAHLN laboratory. The individual specimens may not be pooled by the Accredited Veterinarian (Category II) or any other person other than the NAHLN laboratory testing the samples.
 - x. The person owning or leasing the premises on which the animals are being held for testing prior to shipment into Pennsylvania shall:
 - A. Assure each animal has official identification.
 - B. Provide the USDA APHIS Category II Accredited Veterinarian overseeing the collection of specimens or samples with a manifest setting forth the official identification of each animal.
 - C. The manifest shall set forth the number of animals grouped together for each shipment into Pennsylvania, and the official identification of each animal.
 - D. The manifest shall accompany each shipment of animals to their final destination in Pennsylvania.
 - E. The original manifest, or an accurate copy thereof, shall be provided to the owner or lessor of the destination of the dairy cattle in Pennsylvania.
 - xi. The accredited veterinarian collecting or supervising the collection of the diagnostic specimens must have a veterinarian-client-patient relationship with the farm.
 - xii. **Exemptions:** The following exemptions from testing required by this section apply:
 - A. Dairy Cattle less than 1 year of age (calves) are not required to be tested for Influenza A Virus prior to shipment into Pennsylvania.
- d. **Test Results and Movement:**
- i. Where a non-negative test result is obtained on any animal within a group of animals that has been grouped for shipment as required in c. iii, no animal in that group may be imported into, stopped off in, or unloaded in Pennsylvania.
 - ii. Testing evidencing a Negative or Not Detected test result for each animal required to be tested in accordance with section c. must accompany each shipment. A copy of the test results is acceptable.
 - iii. The test results shall provide the official identification of each animal tested.

Recommendations:

1. A current rabies vaccination administered by a licensed veterinarian is recommended for animals 3 months of age and older (observe appropriate slaughter withdraw time).

13. Only one holder per animal will be allowed in the judging ring at any time (except when showing group, one extra handler may be allowed).
14. Any animal of unthrifty nature, unsuitable condition or which cannot be satisfactorily handled under show conditions, will be removed from the Fairgrounds.
15. **Grooming:** Use only grooming products that are approved for use on meat-producing animals when fitting any animal for show. Unapproved products may contain ingredients that result in unacceptable residues in the meat. If it is not certain that a product is residue safe and approved for use on meat animals, don't use it!
16. All information will be posted at the office.
17. **Deadline for Arrival — Thursday, July 18th, 8:00 P.M.**
18. **Released July 21st: Out of State - 7:30 P.M. In-State - 8:30 P.M. ALL stalls must be cleaned.**

Animal Health Regulation Sheep

Section 17: Pennsylvania Sheep

Requirements:

1. Individual official animal identification is required for all sheep. Identification used for sheep must be permanently affixed to the individual animal. Official ID includes:
 - A USDA ear tag with a US shield ; which includes scrapie program tags (animals bearing identification with blue colored scrapie program tags labelled "meat" with a US Shield are not permitted to be exhibited in Pennsylvania. Please call the department at 717-783-6851 if such a tag is encountered); or
 - A legible tattoo with herd and individual identification recognized in an approved USDA Scrapie database a.k.a. scrapie tattoo (flock ID in the right ear—state postal code and letters/numbers—and individual animal ID in the left ear); or
 - A breed registration tattoo if the animals are accompanied by a registration certificate (copy acceptable) and the tattoo is legible.
2. **Certificate of Veterinary Inspection (CVI) issued 30 days prior to the date of exhibition.**
 - CVI's must include the following statement written on them: All animals must be free evidence of infectious and contagious diseases.
3. For post-exhibition sales the following requirements apply:
 - Market sheep must be documented on sales slips which contain the following information:
 - i. Official identification (as described above)
 - ii. Sale date
 - iii. Sale location
 - iv. Name, address and phone number of the exhibitor
 - v. Hauler contact information
 - vi. Destination name and contact information
 - vii. Total number of animals in the shipment
 - viii. Type of sheep (i.e. meat, wool, specific breed)
 - ix. Signature of consignee agent, or hauler
 - Those slips must follow the sheep to their destination (including slaughter facilities).
 - Sheep which are purchased with the intent of breeding and are traveling via interstate movement must have a valid Certificate of Veterinary Inspection (ICVI) prior to movement to the destination state.
 - A Copy of the sale records slips and a copy of any ICVIs (state above) must be kept for 5 years.

Animal Health Regulation

Sheep

Recommendations:

1. A current rabies vaccination administered by a licensed veterinarian for animals 3 months of age and older (observe appropriate slaughter withdrawal time).

Section 18: Out of State Sheep

Requirements:

1. Federal regulation(USDA) requires a Certificate of Veterinary Inspection(CVI) issued within the 30 days prior to entry into PA.
2. Vesicular Stomatitis (VS) Statement: This applies to states that experienced a VS outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: “All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals were not located within 10 miles of a site where VS has been diagnosed.”
3. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
4. Individual official USDA scrapie animal identification is required. Official scrapie ID includes:
 - A USDA ear tag with a US shield ^{US}; which includes scrapie program tags (animals bearing identification with blue colored scrapie program tags labelled “meat” with a US Shield^{US} are not permitted be exhibited in Pennsylvania- please call the department at 717-783-6851 if such a tag is encountered). or
 - A legible tattoo with herd and individual identification recognized in an approved USDA Scrapie database a.k.a. scrapie tattoo (flock ID in the right ear—state postal code and letters/numbers—and individual animal ID in the left ear); or
 - A breed registration tattoo if the animals are accompanied by a registration certificate (copy acceptable) and the tattoo is legible.
5. For post-exhibition sales the following requirements apply:
 - Market sheep must be documented on sales slips which contain the following information:
 - i.Official identification (as described above)
 - ii.Sale date
 - iii.Sale location
 - iv.Name, address and phone number of the exhibitor
 - v.Hauler contact information
 - vi.Destination name and contact information
 - vii.Total number of animals in the shipment
 - viii.Type of sheep (i.e. meat, wool, specific breed)
 - ix.Signature of consignee agent, or hauler
 1. Those slips must follow the sheep to their destination (including slaughter facilities).
 - Sheep which are purchased with the intent of breeding and are traveling via interstate movement must have a Certificate of Veterinary Inspection (ICVI) prior to movement to the destination state.
 - A copy of the sale records slips as delineated above and a copy of any ICVIs (in the above) must be kept by the sale organizer/extension for 5 years.

Recommendations:

1. A current rabies vaccination administered by a licensed veterinarian for animals 3 months of age and older (observe appropriate slaughter withdrawal time).

Animal Health Regulation Swine

Section 19: Pennsylvania Swine

Requirements:

1. No swine species shall be exhibited in Pennsylvania unless each animal:
 - Is accompanied by a **Certificate of Veterinary Inspection (CVI) issued within 30 days of the exhibition;**
 - i. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
 - Is permanently identified by an official 840 series radio frequency identification (RFID) ear tag and the ear tag number is recorded on the CVI;
 - Has been visually inspected and found to be free of signs of contagious disease immediately prior to unloading at the exhibition by an accredited veterinarian or swine health monitor appointed by the fair board or livestock show committee.
 - Swine health monitors appointed by fairs or show/event organizers must undergo annual online training.
 - i. Swine health monitors must provide a current completion certificate to the fair or show staff they will be performing monitoring services for, prior to the start of the event.
2. All breeding swine exhibitions are to occur prior to the arrival of any market swine. All the following condition apply:
 - Castrated swine shall not be classified as breeding swine
 - Breeding swine must be removed from the animal exhibition premises prior to any market swine arriving.
 - Breeding swine animal exhibitions shall arrive, exhibit, and depart in a period no greater than 72 hours. Time begins when the first swine arrives physically on the fairgrounds whether unloaded from a trailer or not and ends when the last hog physically leaves the premises on a trailer.
 - Swine birthing exhibitions and educational displays which are not competing may occur concurrently with market swine animal exhibition, as long as, reasonable precaution is made to ensure the biosecurity of the swine birthing exhibition or educational display.
 - All market swine exhibited in department sponsored market shows shall move directly to a PDA or USDA licensed slaughter facility following the animal exhibition and may not be diverted to premises other than a recognized slaughter establishment or a slaughter market in which the sales are designated slaughter only sales.

Section 20: Out of State Swine

Requirements:

1. No swine species shall be exhibited in Pennsylvania unless each animal:
 - A Certificate of Veterinary Inspection (CVI) issued within the 30 days prior to the date of the show is required. The CVI shall include a statement verifying that the swine have not been fed raw garbage.
 - i. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
 - Individual animal ID- must be permanently identified by an official 840 series radio frequency identification (RFID) ear tag and the ear tag number is recorded on the CVI.
 - Has been visually inspected and found to be free of signs of contagious disease immediately prior to unloading at the exhibition by an accredited veterinarian or swine health monitor appointed by the fair board or livestock show committee.

- Swine health monitors appointed by fairs or show/event organizers must undergo annual online training.
 - i. Swine health monitors must provide a current completion certificate to the fair or show staff they will be performing monitoring services for, prior to the start of the event.

- 4. Vesicular Stomatitis (VS) Statement: This applies to states that experienced a VS outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals were not located within 10 miles of a site where VS has been diagnosed."
- 5. Brucellosis Testing Requirements:
 - No test required if the animal originates from a validated brucellosis-free state or brucellosis-free herd. All others must be tested negative within the 30 days prior to the date of importation. The date of test and test results must be included on the CVI.
- 6. Pseudorabies Testing Requirements:
 - No test required if the animal originates from a Qualified Pseudorabies-free herd within a Pseudorabies free state. All others must be tested negative within 30 days prior to the date of importation. The date of test and test results must be included on the CVI.

1. **Each exhibitor is required to turn in a VCPR to the Superintendent with all entered animals listed at check-in.**
2. This Show is sanctioned by the American Dairy Goat Association and ADGA rules shall govern. The Junior and senior shows are not separately sanctioned. The order of the show is not subject to change.
3. **No more than two entries per class to the same exhibitor.**
4. Entries showing breed and class number must be made on approval forms which will be provided upon request. All fees must accompany entries, which must be made no later than June 17th, 2024. The management reserves the right to limit the number of entries of any exhibitor.
5. Use a separate line for each animal & group classes. Keep each breed together & class numbers in order. Entries in Breeder's Young Herd, Dairy Herd, Best Udder & Best Doe Bred by exhibitor shall be made using the class name.
6. The base date for computing the age of the animal is Show Day.
7. Get of Sire shall consist of 3 does. Sire need not be owned by the exhibitor. Entries in this class shall be made in the name of the Sire. **(Limited to ONLY 2 entries)**
8. Entries in Dam/Daughter & Produce of Dam shall be made in the name of the Dam. **(Limited to ONLY 2 entries)**
9. Dairy Herd shall consist of 3 milking does of one breed, any age **(Limited to ONLY 1 entry)**
10. Breeder's Young Herd shall consist of 3 Junior does under 2 years of age, not in milk. Does must be owned and bred by exhibitor. **(Limited to ONLY 2 entries)**
11. Only the original registration certificate will be accepted for all animals. Proof of ownership shall be the name on the registration certificate. All names included on one identification number constitute only one membership, therefore only one exhibitor. Only the ID number on the registration certificate is proof of ownership. Persons showing animals whose registration certificate have signed transfers that have not been processed by the ADGA office must show those animals in the owner's name shown on ADGA records at that time. This must be presented to the superintendent at time of arrival.
12. Permanent Champions may be shown in either the appropriate age class or the Champion's Challenge Class. Proof of championship can be either the prefix CH, GCH or SGCH as affixed by ADGA on the animal's registration/recordation certificate or presentation of the notification letter, issued by ADGA, in conjunction with the original registration/recordation certificate. The letter is valid for use until December 31 of the year of issuance, after which the certificate of registration/recordation must be officially updated (if using for show purposes).



Section 11: Pennsylvania Goats

Requirements:

1. Individual official animal identification is required for all goats. Identification used for goats must be permanently affixed to the individual animal. Official ID includes any of the following:
 - A USDA ear tag with a US shield ; which includes scrapie program tags (animals bearing identification with blue colored scrapie program tags labelled “meat” with a US shield  are not permitted to be exhibited in Pennsylvania. Please call the department at 717-783-6851 if such a tag is encountered); or
 - A legible tattoo with herd and individual identification recognized in an approved USDA Scrapie database a.k.a. scrapie tattoo (flock ID in the right ear—state postal code and letters/numbers—and individual animal ID in the left ear);
 - A breed registration tattoo if the animal is accompanied by a registration certificate and the tattoo is legible.
2. Certificate of Veterinary Inspection (CVI) issued 30 days prior to the date of exhibition.
 - CVI's must include the following statement written on them: All animals must be free evidence of infectious and contagious diseases.

Section 12: Out of State Goats

Requirements:

1. A Certificate of Veterinary Inspection (CVI) issued within 30 days prior to the date of importation into Pennsylvania.
2. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
3. Individual official animal identification is required for all goats. Identification used for goats must be permanently affixed to the individual animal. Official ID includes any of the following:
 - A USDA ear tag with a US shield ; which includes scrapie program tags (animals bearing identification with blue colored scrapie program tags labelled “meat” with a US shield  are not permitted to be exhibited in Pennsylvania. Please call the department at 717-783-6851 if such a tag is encountered); or
 - A legible tattoo with herd and individual identification recognized in an approved USDA Scrapie database a.k.a. scrapie tattoo (flock ID in the right ear—state postal code and letters/numbers—and individual animal ID in the left ear);
 - A breed registration tattoo if the animal is accompanied by a registration certificate and the tattoo is legible.
4. Vesicular Stomatitis (VS) statement: This applies to states that experienced a VS outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: “All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals were not located within 10 miles of a site where VS has been diagnosed.”
5. Tuberculosis testing requirements:
 - No test is required for animals originating from states or zones designated as accredited-free by the USDA.
 - All animals originating from states or zones designated modified accredited advanced by the USDA must be test negative within the 60 days prior to the date of importation. The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original report is acceptable).

The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original test report is acceptable).
 - All goats shall comply with the Department's “Interstate Order of Quarantine; Tuberculosis Testing requirements for Importation of Cattle, Bison, Goats, or Camelids” [49 Pa.B. 709, Saturday, February 16, 2019).

Section 3: Pennsylvania Cattle:

Requirements:

1. Cattle shall be identified by an official ear tag or other unique identification device approved by PDA. Official identification includes:
 - A USDA- issued National Uniform Ear tagging System (NUES) ear tag having a US shield ; or
 - A 15 digit Animal Identification Number (AIN) ear tag starting with "840" and having a US shield
2. **Certificate of Veterinary Inspection (CVI) issued 30 days prior to the date of exhibition.**
 - CVI's must include the following statement written on them: All animals must be free evidence of infectious and contagious diseases.
3. Rodeo: It is required that rodeo cattle of all ages be negative of an official tuberculin test within 60 days prior to the start of the fair unless they are members of and originate from an accredited tuberculosis-free herd. The cattle can be accompanied by the negative test report or the tuberculosis test results can be recorded by the veterinarian on a CVI or VCPR.


Recommendations:

1. A current rabies vaccination administered by a licensed veterinarian is recommended for animals 3 months of age and older (observe appropriate slaughter withdraw time).

Section 4: Out of State Cattle:

Requirements:

1. Federal regulations (USDA) require a Certificate of Veterinary Inspection (CVI) issued within the 30 days prior to the date of importation.
2. Vesicular Stomatitis (VS): This applies to cattle entering Pennsylvania from states that experienced a Vesicular Stomatitis outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals have neither been exposed to VS nor were located within 10 miles of a site where VS has been diagnosed."
3. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
4. Federal regulation (USDA) requires individual official animal identification for all cattle of any age of exhibition. Official ID will have a US shield  and includes:
 - A USDA-issued National Uniform Eartagging System (NUES) tag; or
 - A 15-digit Animal Identification Number (AIN) ear tag starting with "840"; or
5. Tuberculosis testing requirements:
 - No test is required for animals originating from states or zones designated as accredited free by the USDA.
 - All animals originating from states or zones designated modified accredited advanced by the USDA must be test negative within 60 days prior to the date of importation. The negative test results and dates of tests must be included on the CVI or the animal must be accompanied by a negatives test report (a copy of the original report is acceptable).
 - All animals originating from states or zones designated modified accredited by the USDA must originate from herds in which all animals 12 months of age and older are test negative within the 12 months prior to the date of importation and the individual animals (all ages) to be imported are also test negative within the 60 days prior to the date of importation and at least 60 days after the negative whole herd test was completed. The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original test report is acceptable).
 - **Special Tuberculosis Test requirement for Rodeo Cattle:** All rodeo cattle and bison from out of state must be negative on an official tuberculosis test within 60 days prior to entering Pennsylvania unless they originate from and are members of an Accredited Tuberculosis-free herd within an accredited Tuberculosis-free state or zone. This requirement for rodeo cattle from out of state is in addition to all other requirements listed above for out of state cattle.

4-H/FFA Rules & Regulations:

1. ALL 4-H/FFA exhibitors must be meet one or both of the following criteria below:
 - a. **4-H Members and Clubs:** Eligible to Exhibit: **York County** 4-H Club members (active) carrying a project under the supervision of the Pennsylvania State University / York County Extension Service. Members age will be determined as of January 1st of the current year for classes where members enter based on age. 4-H members 8-18 years old are eligible to enter the junior livestock show.
 - b. **FFA:** Eligible to Exhibit: FFA members on the current roster of a Nationally Chartered FFA Chapter carrying a project (SAE) in classes entered. Age of members will be determined as of January 1 of the current year for classes where members enter based on age.
 - i. Members who have not passed their 21st birthday by January 1 of the current year are eligible to enter the junior livestock show.
2. **Read ALL rules on pages 3-6!**
3. All Livestock entries are required to meet **2024 Pennsylvania Animal Livestock Health Requirements**.
4. **4-H/FFA exhibitors are reminded to observe all general and special rules and conduct themselves in a proper way on the Fairgrounds to avoid forfeiture of privileges and/or premiums.**
5. **ALL 4-H/FFA are required to sign & turn in the Code of Show Ring Ethics to the Junior Livestock Office!**
6. **4-H/FFA Showmanship Age is the age of the exhibitor as of January 1st of the current year.**

4-H/FFA Supreme Market Animal Contest

Supported by: Cold Spring Farm and Pet, LLC, Bill Carpenter

The Supreme Champion Market Animal will be selected by an appointed judge who will be familiar with all the species (beef, dairy beef, meat goats, sheep, and swine). The judge will evaluate the Grand Champion 4-H/FFA Market animal from each species (beef, dairy beef, meat goats, sheep, and swine). They are to keep in mind the primary function of the market animal is for meat production. Frame size and structural correctness are examined, but to a slightly lesser degree than in the breeding portion of each species.

The appointed judge will alone select the 4-H/FFA Supreme Market Animal. All decisions are final. There is no monetary award, but the 4-H/FFA Supreme Market Animal will be the first animal to sell in the Junior Livestock Sale. The contest is meant to be fun and educational to the public.

4-H/FFA Supreme Showmanship Contest

Supported by: Helena Agri-Enterprises LLC

Each species will have the opportunity to have the Grand Champion Showman for that species compete in a Round Robin competition for the York State Fair Supreme Junior Showman. The species that will be represented are: Beef, Dairy Beef, Meat Goats, Sheep, and Swine.

If the species Champion Showman wins in more than one specie, they must select which species they wish to show and the Reserve Champion Showman will represent the alternate species. In the event that the Grand and Reserve Showman in a species are already selected to show and there is a vacancy to show a species, the showman in the honorable mention position (selected by the showmanship judge of each species during their specie show) will represent that species.

Each champion showman will procure an animal from each species to show. The animal must have been exhibited in the contest year at the York State Fair. The champion showman may use their own animal or select another animal.

Each showman will need to have proper equipment in the ring during the show. They may borrow equipment from other members.

The Supreme Champion 4-H/FFA Showman will be selected by an appointed judge who will be familiar with how all the species are shown. The judge will place the showman in each round, ranking them 1st-5th place on a scorecard. Each placing is valued at their numerical value (ex. – 1st = 1 point, 2nd = 2 points, 3rd = 3 points, etc.) The numerical values of each placing will be tallied from all of the rounds and the showman with the lowest score, wins. In the event of a tie, the appointed judge will make the final decision. There will be no premiums associated with this contest.

4-H/FFA PeeWee Showmanship

The PeeWee Showmanship is for kids between 5 - 7 years old by the date of the show. PeeWee classes will be included in the Beef, Sheep, Swine, Dairy, Dairy Beef, Goats and Alpaca shows. Each species superintendent will post the time of the PeeWee class. Participants, especially in Beef, are encouraged to have an older 4-H or FFA member assist them in the ring while exhibiting their animal. Each participant will receive a ribbon and additional items to be determined by the class sponsor. PeeWee participants will not receive premiums. All PeeWee participants MUST inform the species superintendent during check in if they wish to participate in the PeeWee class.

 - CVI's must include the following statement written on them: All animals must be free evidence of infectious and contagious diseases.

Recommendations:

1. A current rabies vaccination administered by a licensed veterinarian is recommended for animals 3 months of age and older (observe appropriate slaughter withdraw time).

Animal Health Regulation

CATTLE

Section 4: Out of State Cattle:

Requirements:

1. Federal regulations (USDA) require a Certificate of Veterinary Inspection (CVI) issued within the 30 days prior to the date of importation.
2. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
3. Vesicular Stomatitis (VS): This applies to cattle entering Pennsylvania from states that experienced a Vesicular Stomatitis outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals have neither been exposed to VS nor were located within 10 miles of a site where VS has been diagnosed."
4. Federal regulation (USDA) requires individual official animal identification for all cattle of any age of exhibition. Official ID will have a US shield  and includes:
 - a. A USDA-issued National Uniform Eartagging System (NUES) tag; or
 - b. A 15-digit Animal Identification Number (AIN) ear tag starting with "840"; or
5. Tuberculosis testing requirements:
 - a. No test is required for animals originating from states or zones designated as accredited free by the USDA.
 - b. All animals originating from states or zones designated modified accredited advanced by the USDA must be test negative within 60 days prior to the date of importation. The negative test results and dates of tests must be included on the CVI or the animal must be accompanied by a negatives test report (a copy of the original report is acceptable).
 - c. All animals originating from states or zones designated modified accredited by the USDA must originate from herds in which all animals 12 months of age and older are test negative within the 12 months prior to the date of importation and the individual animals (all ages) to be imported are also test negative within the 60 days prior to the date of importation and at least 60 days after the negative whole herd test was completed. The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original test report is acceptable).
 - d. **Special Tuberculosis Test requirement for Rodeo Cattle:** All rodeo cattle and bison from out of state must be negative on an official tuberculosis test within 60 days prior to entering Pennsylvania unless they originate from and are members of an Accredited Tuberculosis-free herd within an accredited Tuberculosis-free state or zone. This requirement for rodeo cattle from out of state is in addition to all other requirements listed above for out of state cattle.
6. **Out of State Dairy Cattle ONLY in accordance with the Quarantine issued Saturday, April 20, 2024:**
 - a. **Importation Standards:** All dairy cattle entering Pennsylvania shall meet all requirements established in the Domestic Animal Law (3 Pa.C.S 2301-2390), the Department's regulations at Title 7 of the *Pennsylvania Code* and in this Quarantine Order.
 - b. **Movement Restrictions:** Dairy Cattle from a premises where Influenza A Virus has been confirmed in dairy cattle, or where the premises meets the UDA case definition, may not be imported into the Commonwealth until the premises has been declared free of disease by the respective State Animal Health Official.
 - c. **Testing Requirements:** Except as proved in subsection xxii., dairy cattle from a State, Commonwealth, foreign nation, province, or territory where Influenza A Virus has been confirmed in dairy cattle within the past 30 days may not be imported into, stopped off in, or unloaded in Pennsylvania without meting the following testing requirements for Influenza A Virus:
 - i. A representative sample of 30 animals in each shipment must be tested for Influenza A Virus within 5 days prior to movement.
 - ii. If a shipment contains 30 or fewer animals, all animals in the shipment must be tested within 5 days prior to movement.
 - iii. The animals in each shipment must have been assembled as a group for a period of at least 30 days prior to testing in accordance with subsections i and ii above. New animals may not have been added to the herd or group within the 30 day period preceding testing.
 - iv. Where the requirements established in subsection iii above have not been or cannot be complied with, all animals in the shipment, no matter the size of the shipment, must be tested in accordance with subsection ii above.

- v. Milk specimens, nasal swabs and samples as required in subsection vi and vii of this section must be collected and submitted by or under the supervision of an Accredited Veterinarian (Category II).
 - vi. Nasal swabs must be collected for testing in accordance with the provisions of this section from each non-lactating animal on a shipment. Nasal swabs shall be collected in a manner that is in accordance with National Veterinary Services Laboratory guidance provided to the testing laboratory.
 - vii. A milk specimen must be collected for testing in accordance with the provisions of this section from each lactating animal on a shipment. Milk specimens must be collected in a manner that is in accordance with National Veterinary Services Laboratory guidance to the testing laboratory.
 - viii. Each specimen or sample collected under subsections vi and vii must be tested for Influenza A Virus using polymerase chain reaction (PCR) testing and protocol approved by NVSL.
 - ix. Testing of all specimens or samples collected under subsections vi and vii must be performed at a NAHLN laboratory. The individual specimens may not be pooled by the Accredited Veterinarian (Category II) or any other person other than the NAHLN laboratory testing the samples.
 - x. The person owning or leasing the premises on which the animals are being held for testing prior to shipment into Pennsylvania shall:
 - A. Assure each animal has official identification.
 - B. Provide the USDA APHIS Category II Accredited Veterinarian overseeing the collection of specimens or samples with a manifest setting forth the official identification of each animal.
 - C. The manifest shall set forth the number of animals grouped together for each shipment into Pennsylvania, and the official identification of each animal.
 - D. The manifest shall accompany each shipment of animals to their final destination in Pennsylvania.
 - E. The original manifest, or an accurate copy thereof, shall be provided to the owner or lessor of the destination of the dairy cattle in Pennsylvania.
 - xi. The accredited veterinarian collecting or supervising the collection of the diagnostic specimens must have a veterinarian-client-patient relationship with the farm.
 - xii. **Exemptions:** The following exemptions from testing required by this section apply:
 - A. Dairy Cattle less than 1 year of age (calves) are not required to be tested for Influenza A Virus prior to shipment into Pennsylvania.
- d. Test Results and Movement:**
- i. Where a non-negative test result is obtained on any animal within a group of animals that has been grouped for shipment as required in c. iii, no animal in that group may be imported into, stopped off in, or unloaded in Pennsylvania.
 - ii. Testing evidencing a Negative or Not Detected test result for each animal required to be tested in accordance with section c. must accompany each shipment. A copy of the test results is acceptable.
 - iii. The test results shall provide the official identification of each animal tested.

Recommendations:

1. A current rabies vaccination administered by a licensed veterinarian is recommended for animals 3 months of age and older (observe appropriate slaughter withdraw time).

Rules & Regulations:

1. **Each exhibitor is required to turn in a VCPR to the Superintendent with all entered animals listed at check-in.**
2. Exhibitors must meet eligibility rules listed on Page 26 and be carrying a sheep animal as a project during the current calendar year.
3. Animals exhibited must be registered and may be entered and shown in open classes by paying the entry fee.
4. Members must show their own project animal to be eligible for premiums. In the event the member has two animals in the same class, a junior member must show the second project animal.
5. Market lambs may be wethers and/or ewes.
 - a. Market wethers must be fully castrated.
6. All market lambs must be slick shorn and shorn within two weeks of the fair.
7. Ewes shown in breeding classes cannot be shown in market classes.
8. To show in any breeding class all entries in the junior sheep breeding show must be registered with their respective breed association, the exception being natural colored sheep. Natural colored sheep must have at least a 2-inch fleece.
9. Market Lamb Pairs may come from individual market lambs in the same weight classes.
10. **Market Lambs must have a full set of lamb teeth. Any animals displaying yearling teeth will be disqualified.**
11. All other breeds are defined as registered animals. This division also includes all sheep registered as Dorset Advantage.
12. Any animal of unthrifty nature, unsuitable condition or which cannot be satisfactorily handled under show conditions, will be removed from the Fairgrounds.
13. **Grooming:** Use only grooming products that are approved for use on meat-producing animals when fitting any animal for show. Unapproved products may contain ingredients that result in unacceptable residues in the meat. If it is not certain that a product is residue safe and approved for use on meat animals, don't use it!
14. **4-H/FFA Showmanship Age is the age of the exhibitor as of January 1st of the current year.**
15. **Deadline for Arrival – Thursday, July 18th, 8:00 P.M.**
 - a. All exhibitors must check in between 5:00 P.M. – 8:00 P.M. to be eligible to show.
16. **Released Sunday – July 21st, 8:30 P.M. with stalls cleaned.**

Section 17: Pennsylvania Sheep

Requirements:

1. Individual official animal identification is required for all sheep. Identification used for sheep must be permanently affixed to the individual animal. Official ID includes:
 - A USDA ear tag with a US shield ^{US}; which includes scrapie program tags (animals bearing identification with blue colored scrapie program tags labelled "meat" with a US Shield^{US} are not permitted to be exhibited in Pennsylvania. Please call the department at 717-783-6851 if such a tag is encountered); or
 - A legible tattoo with herd and individual identification recognized in an approved USDA Scrapie database a.k.a. scrapie tattoo (flock ID in the right ear—state postal code and letters/numbers—and individual animal ID in the left ear); or
 - A breed registration tattoo if the animals are accompanied by a registration certificate (copy acceptable) and the tattoo is legible.

2. Certificate of Veterinary Inspection (CVI) issued 30 days prior to the date of exhibition.

- CVI's must include the following statement written on them: All animals must be free evidence of infectious and contagious diseases.
3. For post-exhibition sales the following requirements apply:
- Market sheep must be documented on sales slips which contain the following information:
 - i. Official identification (as described above)
 - ii. Sale date
 - iii. Sale location
 - iv. Name, address and phone number of the exhibitor
 - v. Hauler contact information
 - vi. Destination name and contact information
 - vii. Total number of animals in the shipment
 - viii. Type of sheep (i.e. meat, wool, specific breed)
 - ix. Signature of consignee agent, or hauler
 - Those slips must follow the sheep to their destination (including slaughter facilities).
 - Sheep which are purchased with the intent of breeding and are traveling via interstate movement must have a valid Certificate of Veterinary Inspection (ICVI) prior to movement to the destination state.
 - A Copy of the sale records slips and a copy of any ICVIs (state above) must be kept for 5 years.

Recommendations:

1. A current rabies vaccination administered by a licensed veterinarian for animals 3 months of age and older (observe appropriate slaughter withdrawal time).

Section 18: Out of State Sheep

Requirements:

1. Federal regulation(USDA) requires a Certificate of Veterinary Inspection(CVI) issued within the 30 days prior to entry into PA.
2. Vesicular Stomatitis (VS) Statement: This applies to states that experienced a VS outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals were not located within 10 miles of a site where VS has been diagnosed."
3. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
4. Individual official USDA scrapie animal identification is required. Official scrapie ID includes:
 - A USDA ear tag with a US shield ^{US}; which includes scrapie program tags (animals bearing identification with blue colored scrapie program tags labelled "meat" with a US Shield^{US} are not permitted be exhibited in Pennsylvania- please call the department at 717-783-6851 if such a tag is encountered). or
 - A legible tattoo with herd and individual identification recognized in an approved USDA Scrapie database a.k.a. scrapie tattoo (flock ID in the right ear—state postal code and letters/numbers—and individual animal ID in the left ear); or
 - A breed registration tattoo if the animals are accompanied by a registration certificate (copy acceptable) and the tattoo is legible.
5. For post-exhibition sales the following requirements apply:
 - Market sheep must be documented on sales slips which contain the following information:
 - i. Official identification (as described above)
 - ii. Sale date
 - iii. Sale location
 - iv. Name, address and phone number of the exhibitor
 - v. Hauler contact information
 - vi. Destination name and contact information
 - vii. Total number of animals in the shipment
 - viii. Type of sheep (i.e. meat, wool, specific breed)
 - ix. Signature of consignee agent, or hauler
 1. Those slips must follow the sheep to their destination (including slaughter facilities).

- A copy of the sale records slips as delineated above and a copy of any ICVIs (in the above) must be kept by the sale organizer/extension for 5 years.

Recommendations:

 - Is permanently identified by an official 840 series radio frequency identification (RFID) ear tag and the ear tag number is recorded on the CVI;
 - Has been visually inspected and found to be free of signs of contagious disease immediately prior to unloading at the exhibition by an accredited veterinarian or swine health monitor appointed by the fair board or livestock show committee.

- Swine health monitors appointed by fairs or show/event organizers must undergo annual online training.
 - i. Swine health monitors must provide a current completion certificate to the fair or show staff they will be performing monitoring services for, prior to the start of the event.

- Castrated swine shall not be classified as breeding swine

3. All market swine exhibited in department sponsored market shows shall move directly to a PDA or USDA licensed slaughter facility following the animal exhibition and may not be diverted to premises other than a recognized slaughter establishment or a slaughter market in which the sales are designated slaughter only sales.

Section 20: Out of State Swine

Requirements:

1. No swine species shall be exhibited in Pennsylvania unless each animal:
 - A Certificate of Veterinary Inspection (CVI) issued within the 30 days prior to the date of the show is required. The CVI shall include a statement verifying that the swine have not been fed raw garbage.
 - i. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
 - Individual animal ID- must be permanently identified by an official 840 series radio frequency identification (RFID) ear tag and the ear tag number is recorded on the CVI.
 - Has been visually inspected and found to be free of signs of contagious disease immediately prior to unloading at the exhibition by an accredited veterinarian or swine health monitor appointed by the fair board or livestock show committee.
 - Swine health monitors appointed by fairs or show/event organizers must undergo annual online training.
 - i. Swine health monitors must provide a current completion certificate to the fair or show staff they will be performing monitoring services for, prior to the start of the event.
2. All breeding swine exhibitions are to occur prior to the arrival of any market swine. All the following condition apply:
 - Castrated swine shall not be classified as breeding swine
 - Breeding swine must be removed from the animal exhibition premises prior to any market swine arriving.

5. Brucellosis Testing Requirements:
 - No test required if the animal originates from a validated brucellosis-free state or brucellosis-free herd. All others must be tested negative within the 30 days prior to the date of importation. The date of test and test results must be included on the CVI.
6. Pseudorabies Testing Requirements:
 - No test required if the animal originates from a Qualified Pseudorabies-free herd within a Pseudorabies free state. All others must be tested negative within 30 days prior to the date of importation. The date of test and test results must be included on the CVI.

Section 12: Out of State Goats

Requirements:

1. A Certificate of Veterinary Inspection (CVI) issued within 30 days prior to the date of importation into Pennsylvania.
2. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.
3. Individual official animal identification is required for all goats. Identification used for goats must be permanently affixed to the individual animal. Official ID includes any of the following:
 - A USDA ear tag with a US shield ; which includes scrapie program tags (animals bearing identification with blue colored scrapie program tags labelled "meat" with a US shield  are not permitted to be exhibited in Pennsylvania. Please call the department at 717-783-6851 if such a tag is encountered); or
 - A legible tattoo with herd and individual identification recognized in an approved USDA Scrapie database a.k.a. scrapie tattoo (flock ID in the right ear—state postal code and letters/numbers—and individual animal ID in the left ear);
 - A breed registration tattoo if the animal is accompanied by a registration certificate and the tattoo is legible.
4. Vesicular Stomatitis (VS) statement: This applies to states that experienced a VS outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals were not located within 10 miles of a site where VS has been diagnosed."
5. Tuberculosis testing requirements:
 - No test is required for animals originating from states or zones designated as accredited-free by the USDA.
 - All animals originating from states or zones designated modified accredited advanced by the USDA must be test negative within the 60 days prior to the date of importation. The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original report is acceptable).
 - All animals originating from states or zones designated modified accredited must originate from herds in which all animals 12 months of age and older have tested negative within the 12 months prior to the date of importation; and the individual animals (all ages) to be imported have also tested negative within the 60 days prior to the date of importation and at least 60 days after the negative whole herd test was completed. The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original test report is acceptable).
 - All goats shall comply with the Department's "Interstate Order of Quarantine; Tuberculosis Testing requirements for Importation of Cattle, Bison, Goats, or Camelids" [49 Pa.B. 709, Saturday, February 16, 2019].
6. For post-exhibition sales the following requirements apply:

 - ii. Sale date
 - iii. Sale location
