**WHO:** Youth with an intellectual disability between the ages of 8-18 years of age. Each participant will be paired with two youth mentors and a pig.

**WHERE:** Fond du Lac County Fair Livestock Barn (Meet and Greet and Mentor Time) Cow Palace (Group Picture and Show)

The show ring, located in the Cow Palace, is surrounded by a fence to contain the pigs and keep them near the judge. The judge will assess how the mentors, participants and pig work together as a cohesive unit. There are bleachers surrounding the show ring for spectators to view.

**COST:** No cost to participate, however must be pre-registered by July 1. This is limited to the first 20 registered participants.

**SHOW ATTIRE:** Closed toe shoes, long pants and A Special Final Drive t-shirt provided upon arrival at the fair.

**REGISTRATION DEADLINE:** Postmarked July 1, 2021

**PLEASE NOTE:** There are a variety of activities, lights and sounds at the Fond du Lac County Fair, in the Livestock Barn and Cow Palace.
