

Dear Potential New KVLS Member:

On behalf of the Board of Directors of the Kissimmee Valley Livestock Show and Fair, Inc., we would like to thank you for your interest in membership within our organization. It is the objective of this organization to conduct and operate the events and activities of the Osceola County Fair held each February. As a new member you will be encouraged to document volunteer hours during the fair, and off-season activities and events.

Membership to this organization is open to any resident of Osceola County, Florida who is a qualified elector of Osceola County, who is interested in the objectives of the organization. Upon approval by a Majority vote of the Board of Directors, you may become a member of the organization. But, first there is a process in order to be granted membership into our organization. The membership application process is detailed below:

- Completed application- Any member may obtain a membership application from the Fair Office for a proposed new member. A completed application along with all signatures met be submitted or postmarked into the KVLS office, by close of business on August 1,2020. N Late applications or incomplete applications will be accepted for membership. (Must have sponsor & chairperson signatures.)
- Along with the completed application there is a non-refundable \$25.00 new membership application fee, due to be submitted or postmarked by August 1, 2020 in the KVLS office.
- All applicants must provide full name, driver's license number and voter ID number. This information will be used to do a background check.

Once the background check is completed and references checked the membership committee will either recommend or not recommend you to the board for membership into our organization. The membership committee will present a list of potential new members to the Board at the September general membership meeting and the Board will vote on new members at the October general membership meeting. After approval for membership, you will be placed on the signing chairperson's committee. If you are interested in other committees, you will need to contact each chairperson to see if their committee needs more help. The fair office has a list of current committee chairpersons and their contact number/ email address.

Annual membership dues for the Kissimmee Valley Livestock Show and Fair, Inc. will be \$20.00 per person. After approval for membership, you will receive a welcome letter, dues statement and badge survey. Your dues need to be paid by October 31st, 2020. if you miss the deadline, the application process will apply if seeking to rejoin the organization. Thereafter, membership dues will be payable by the first business day in April. Non-payment by the first business day in April will result in forfeiting of membership to the organization, and then the application process will apply if seeking to rejoin the organization.
