

Jimmy Morgan Swine Showdown December 4-5,2020

General Rules

1. Entry forms must be signed, complete, and received with entry fee to be accepted. Register two different ways, paper entry or online entry. www.osceolacountyfair.com
2. Show is open to all youth from any state, age 21 or younger as of September 1,2020.
3. No limit to the number of animals you can show.
4. Swine will be judged on current and future potential market characteristics in purebred and market show.
5. Gates open at 9am on Friday morning. State Inspector will be on the grounds Friday from 9am to 5pm, Saturday from 6am to 10am. All hogs must remain on the trailers until checked by the State Inspector. **NO EXCEPTIONS.**
6. All animals must be checked in between 2-5 pm on Friday, and 6-9am on Saturday. Scales will open at 2pm on Friday. Pre-registration is strongly recommended. **SAME DAY ENTRIES MUST BE REGISTERED BY 5pm ON FRIDAY.**
7. ALL swine are required to have a Certificate of Veterinary Inspection (CVI). All out of state swine must also have a Florida permit number on the health papers. Permit numbers can be obtained by your veterinarian by contacting Doyle Conner at (850) 410-0900. Gilts 6 months or older must be tested for Brucellosis and Pseudorabies and CVI must be issued within 30 days for OUT-OF-STATE exhibitors or within 90 days for INSTATE exhibitors of the show day - January 9, 2021. Show organizers reserve the right to refuse any entry that exhibits unhealthy characteristics, based on the state vet inspection.
8. Barrows and gilts only, NO Boars will be allowed.
9. All crossbreds must have a readable ear tag; Purebreds can use the ear notch system.
10. Showing off trailer is encouraged as parking spaces allow. Trailer parking is first come, first served basis.
11. Space will be available for minimal washing and grooming.
12. All crossbred classes will be split based on weight, purebred will be shown by age (born on or after June 1st, 2020).
13. Maximum weight for all hogs at this show will be 350 lbs.
14. The judge's decisions are final in all classes.
15. Any youth 21 or younger as of September 1, 2020, is permitted to show in showmanship if an exhibitor will allow them to use his or her pig.
16. Showmanship will be grouped by ages as follows: Novice (8 and under), Junior (9-12), Intermediate (13-16), Seniors (17-21).
17. Show officials reserve the right to make changes deemed to be in the best interest of the show, in accordance with the guidelines of the Florida Junior Swine Circuit.
18. Class payout amounts will be based on entries and decided at the discretion of the show committee.
19. Weather permitting, all animals must be removed 2 hours following conclusion of the show.
20. **All exhibitors are responsible for cleaning pens prior to leaving barns.**
21. ONLY shavings may be used in pens. Additional shavings may be desired and must be provided by exhibitor.
22. Neither the show committee, or the Kissimmee Valley Livestock Show & Fair Association will be responsible for any accidents or injuries that occur, be responsible for any lost or stolen personal items or damages to personal property.
23. Order of show: Friday, 7pm with breeding gilts. Saturday, 10:30am with showmanship followed by the prospect show.
